ARTICLE IV DURABILITY PROVISION

This power of attorney is intended to be a durable power of

attorney and this durable power of attorney shall not be affected by my disability except as provided by statute. It revokes any and all general durable powers of attorney which have heretofore been given by me and shall become effective upon my disability, incompetency or incapacity.

ARTICLE V ADMINISTRATIVE PROVISIONS

- A. SEVERABILITY. If any part of any provision of this instrument shall be invalid or unenforceable under applicable law, such part shall be ineffective to the extent of such invalidity only, without in any way affecting the remaining parts of such provision or the remaining provisions of this instrument.
- B. INTERPRETATION AND GOVERNING LAW. This instrument is to be construed and interpreted as a general durable power of attorney. The enumeration of specific powers herein is not intended to, nor does it limit or restrict the general powers herein granted to my Agent. This instrument is executed and delivered in the State of Alabama, and the laws of the State of Alabama shall govern all questions as to the validity of this power and the construction of its provisions.
- c. THIRD-PARTY RELIANCE. Third parties may rely upon the representations of my Agent to all matters relating to any power granted to my Agent, and no person who may act in reliance upon the representations of my Agent or the authority granted to my Agent shall incur any liability to me or my estate as a result of permitting my Agent to exercise any power.
- D. TERMINATION. This Power of Attorney may be terminated by the Principal at any time, except during periods of disability, incompetency or incapacity, by delivering written notice of such termination to the Agent. Said power of attorney

shall be terminated upon receipt of said notice by the Agent.


