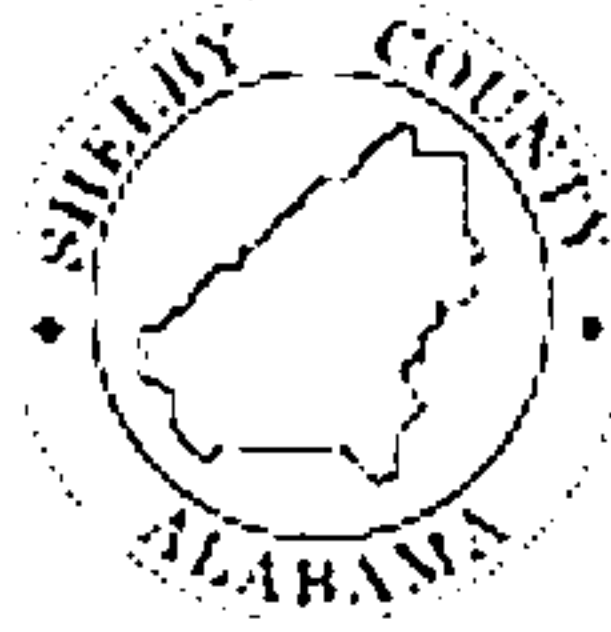


RELEASE OF MORTGAGE

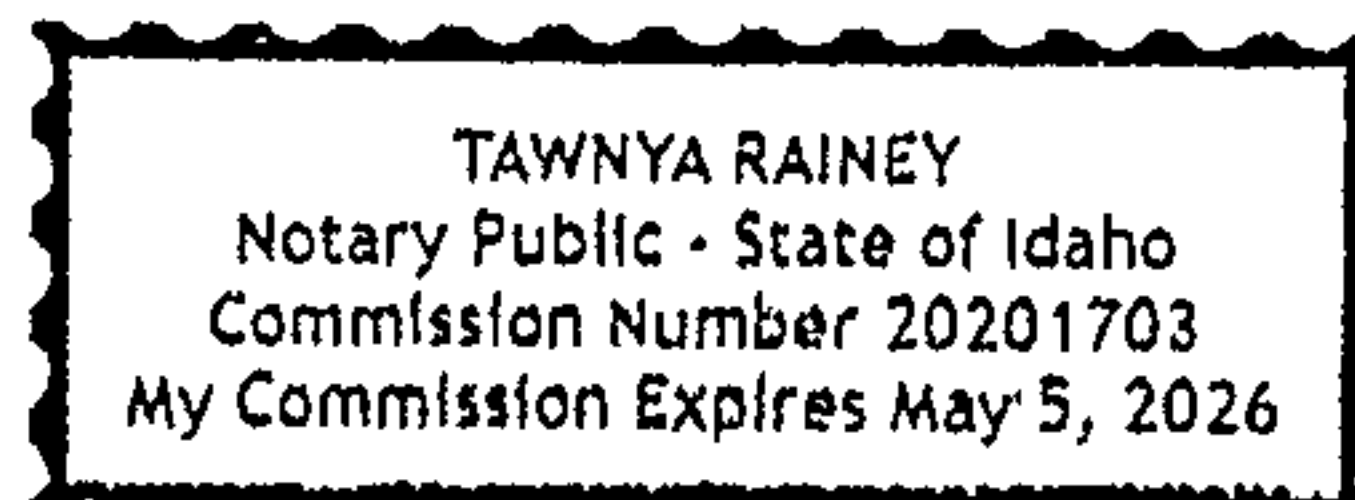
