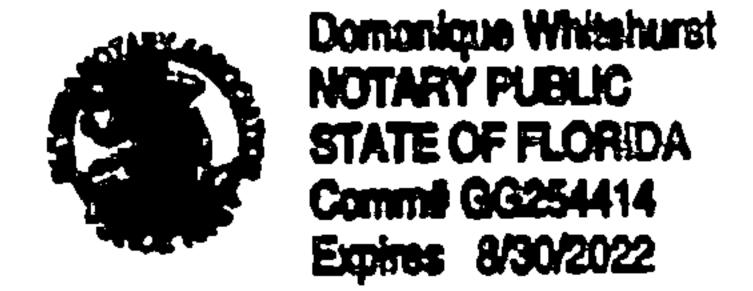

PARCEL 1: From the NW corner of the NW 1/4 of the NE 1/4 of Section 13, Township 21 South, Range 3 West, run easterly along the North line of said 1/4-1/4 section 411.96 feet to the point of beginning of land herein described; thence turn right an angle of 90 degrees 53 minutes and run southerly 522.45 feet, more or less, to a point on the northerly right of way of Shelby County Highway No. 26; thence run northeasterly along said right of way 930.0 feet, more or less, to a point on the intersection of said right of way and the North line of said 1/4-1/4 section; thence run westerly along the North line of said 1/4-1/4 section 736.85 feet to point of beginning.
