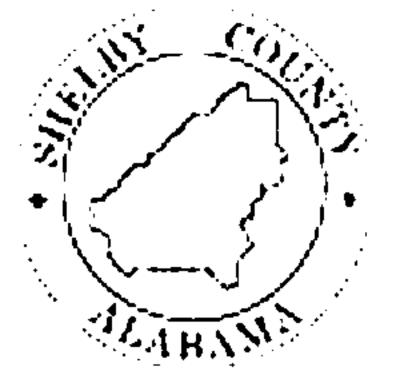

## EXHIBIT "A" LEGAL DESCRIPTION

Commence at the NW corner of the SE 1/4 of NW 1/4, Section 8, Township 24 North, Range 15 East, Shelby County, Alabama, this point being at the West end of Richard Porter Drive (paved County Road) also where Wilderness Trail (County gravel road) intersects said paved County Road; thence South 1 degrees 30 minutes East a distance of 767 feet; thence East a distance of 812 feet to the Point of Beginning of one acre tract described herein; thence continue East a distance of 210 feet; thence South 210 feet; thence West 210 feet; thence North 210 feet to the Point of Beginning.
