

Certificate of Formation of

THE UNDERSIGNED, for the purpose of forming a limited liability company (the "Company") pursuant to the provisions of the Alabama Limited Liability Company Law (the "LLC Law"), does hereby adopt the following Certificate of Formation:

<u>ARTICLE I</u>

The name of the Company is: Estimated Profits L.L.C.

ARTICLE II

The existence of the Company shall commence on the date of the filing of this Certificate of Formation in the Office of the Judge of Probate of Shelby County, Alabama, and shall continue in perpetual existence; *provided, however*, that the Company shall be dissolved prior to such date upon the earlier to occur of (i) the written consent of all the members to dissolve the Company; (ii) as provided in the Operating agreement; or (iii) as may be required under LLC Law.

ARTICLE III

The Purposes for which the Company is organized are:

- (a) to engage in the ownership and leasing of real property; and
- (b) to engage in any lawful act or activity for which limited liability companies may be organized under the LLC Law.

ARTICLE IV

ARTICLE VII

The members of the Company shall have the right to continue its business after an event of dissociation terminates the continued membership of a Member in the Company if a new Member is immediately admitted upon the terms and conditions set forth in the Operating Agreement, and the legal existence and business of the Company is continued by the written consent of any other Members within 90 days after the occurrence of such event of dissociation.

ARTICLE VIII

The Company shall be managed by a Managing Member. The initial Managing Member is Jason Pruitt. The initial Managing Member's address is 812 Rosebury Road, Helena, AL 35080.


