THAT IN CONSIDERATION OF **Two Hundred Forty-Eight Thousand Dollars and NO/100 (\$248,000.00)** to the undersigned grantor, in hand paid by the grantees herein, the receipt whereof is acknowledged, I, **Charles Edward Hadden and Vickie J. Hadden, a married couple**, (herein referred to as grantors), grant, sell, bargain and convey unto, **Loy O. Vaughan, Jr. and Suzanne D. Vaughan** (herein referred to as grantees), for and during their joint lives as joint tenants with rights of survivorship and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder or right of reversion, the following described real estate, situated in Shelby County, Alabama to wit:
