**FORECLOSURE DEED**

KNOW ALL MEN BY THESE PRESENTS, that, whereas, heretofore on February 21, 2007, to-wit: Robert F. Cook, took title as Robert J. Cook and Virginia J. 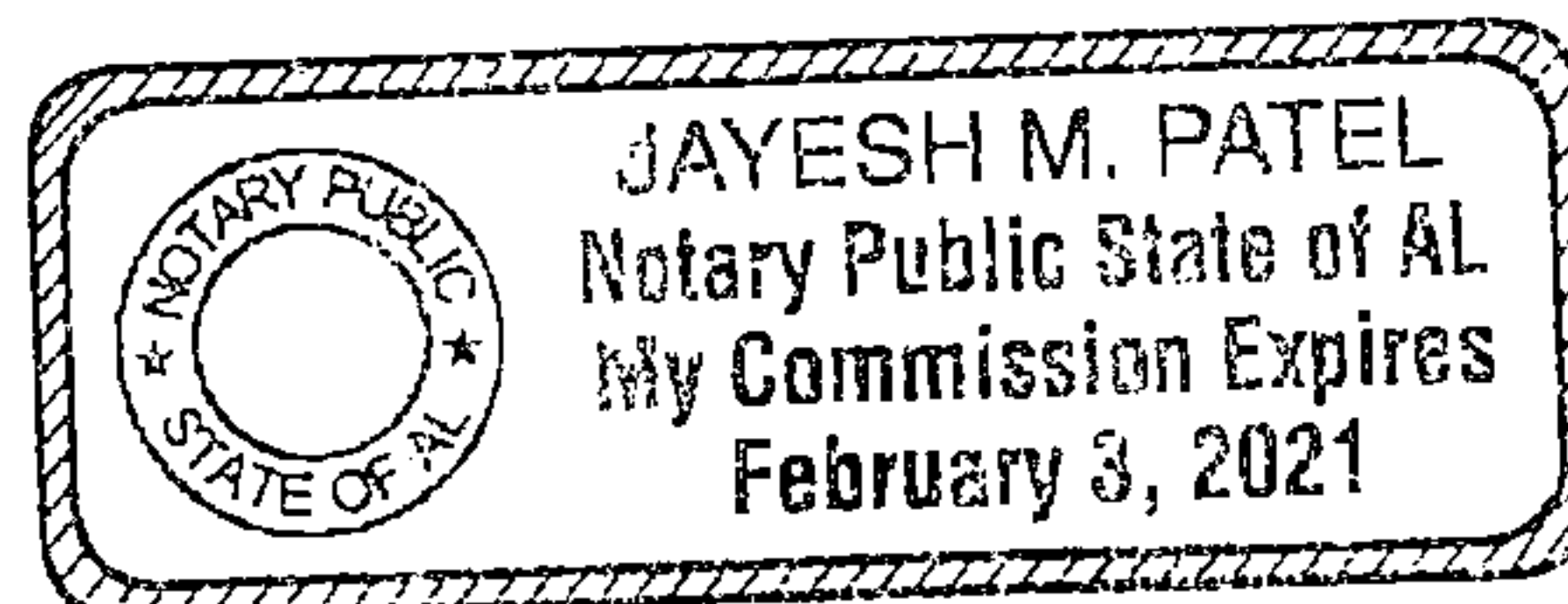
