Shelby County, Alabama, to wit:

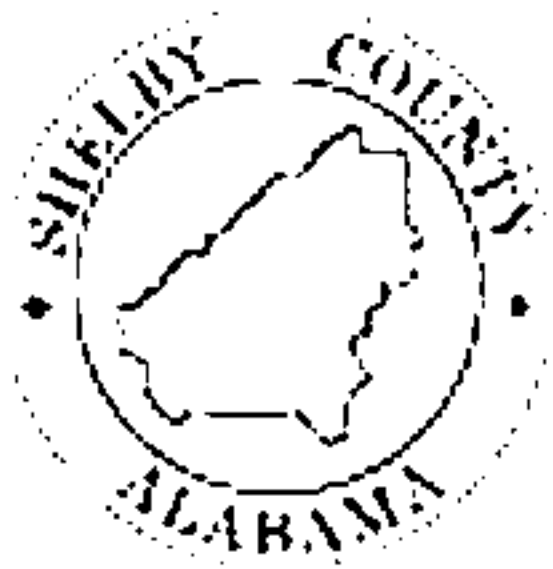
Lot 418, according to the Final Plat of the Subdivision of Lake Wilborn,
