

**AFFIDAVIT OF FACTS CONCERNING THE IDENTITY OF HEIRS**

Before me, the undersigned authority, on this day personally appeared Lawrence Johnson ("Affiant") who, being first duly sworn, upon his/her oath states:

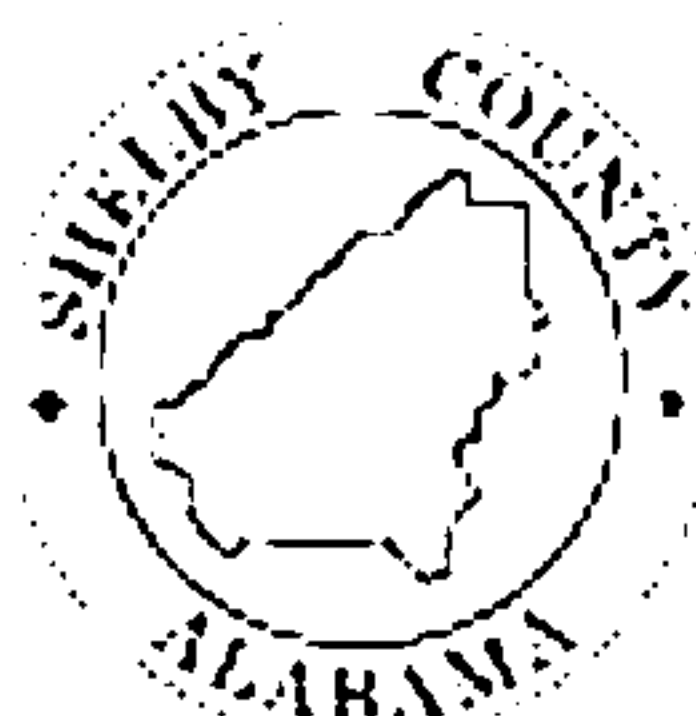
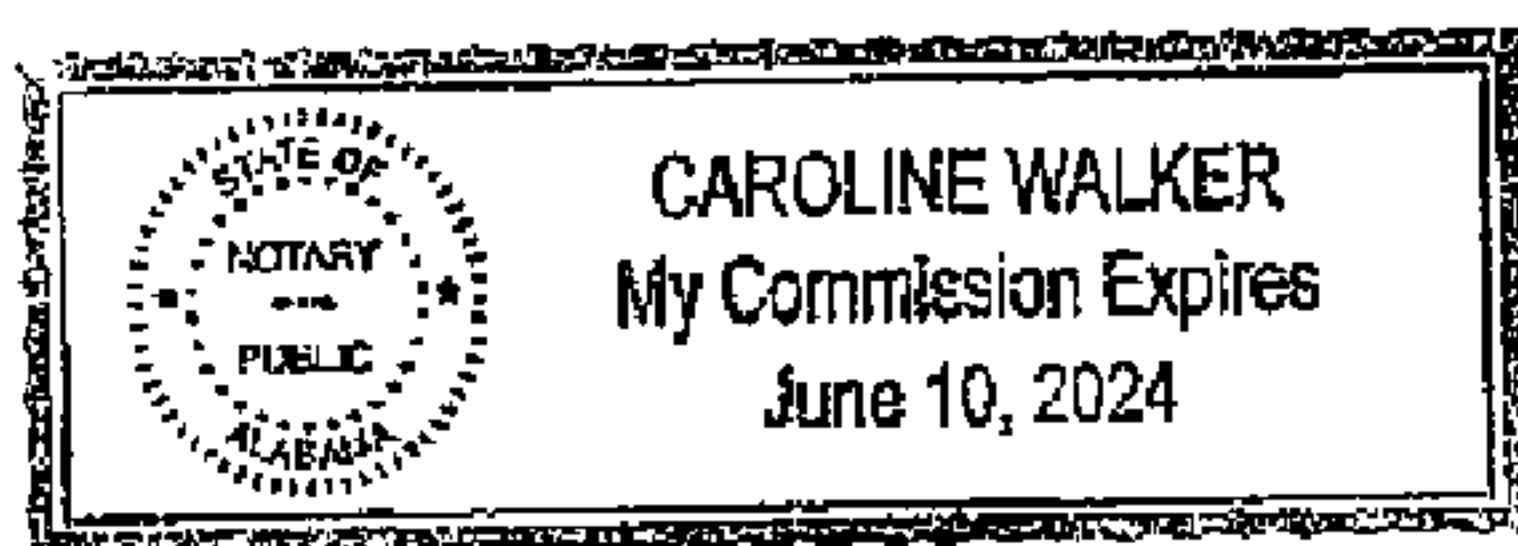
