KNOW ALL MEN BY THESE PRESENTS, that for and in consideration of the sum of Nine Thousand Seven Bundred & no/100---dollar(s), cash in hand paid to the undersigned by the State of Alabama Department of Transportation, the receipt of which is hereby acknowledged, I (we), the undersigned grantor(s), Betty Jo Ray, unmarried, Michael E. Ray, married and Tracy R. Pickett, married have this day bargained and sold, and by these presents do hereby grant, bargain, sell and convey unto the State of Alabama the following described property:

PROPERTY CONSTITUTES NO PART OF THE HOMESTEAD OF GRANTORS OR THEIR RESPECTIVE SPOUSE.

A part of the SE ¼ of the SW ¼ of Section 14 Township 21-S, Range 3-W, identified as Tract No. 35 on Project No. STPBH-0119(510) in Shelby County, Alabama, and being more fully described as follows:

## Parcel 1 of 1:

Commencing at the SE corner of SE ¼ of SW ¼ of Section 14, Township 21-S, Range 3-W;

thence northerly and along the section line a distance of 279.00 feet, more or less, to a point on the present north R/W line of CR-12 (Smokey Rd);

thence westerly and along said present R/W line a distance of 791.00 feet, more or less, to a point on the acquired R/W line (said point offset 28.95' LT and perpendicular to centerline of project at station 25+00.00);

thence southwesterly and along the acquired R/W line a distance of 48.00 feet, more or less, to a point on the grantor's east property line, which is the point and place of BEGINNING;

thence S 9°54'26" W and along the grantor's said property line a distance of 9.87 feet to a point on the present north R/W line of CR-12 (Smokey Rd);

thence S 71°39'56" W and along said present R/W line a distance of 70.62 feet to a point on the present north R/W radius of CR-12 (Smokey Rd);

thence following the curvature thereof an arc distance of 163.16 feet and along said present R/W radius to a point on the acquired R/W line (said point offset 77.12' LT and perpendicular to centerline of project at station 22+24.22) (said arc having a chord bearing of S 89°53'49" W, a clockwise direction, a chord distance of 160.48 feet and a radius of 259.12 feet);

thence N 81°59'49" E and along the acquired R/W line a distance of 231.47 feet to the point and place of BEGINNING, containing 0.097 acre(s), more or less.

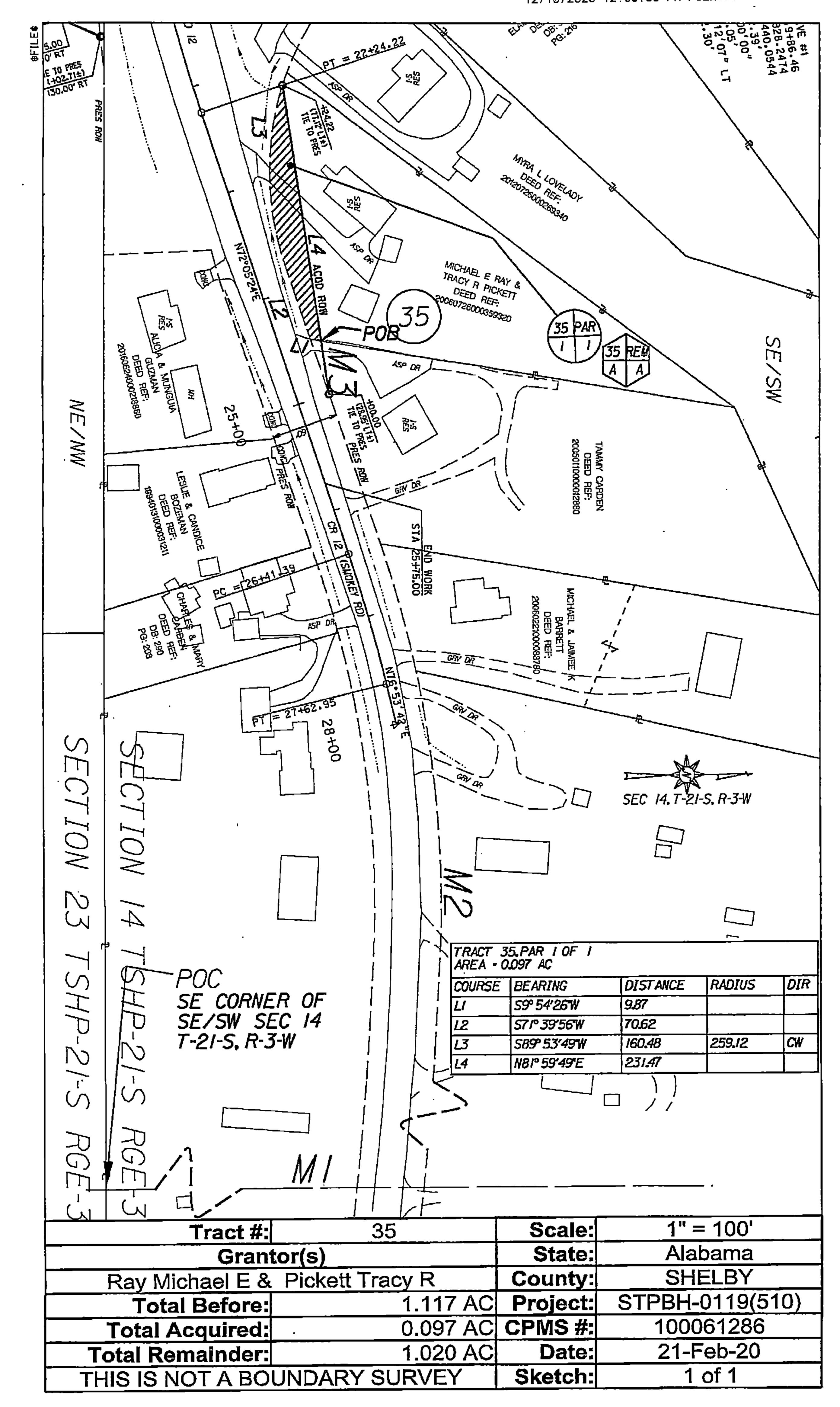
