SUBJECT TO:

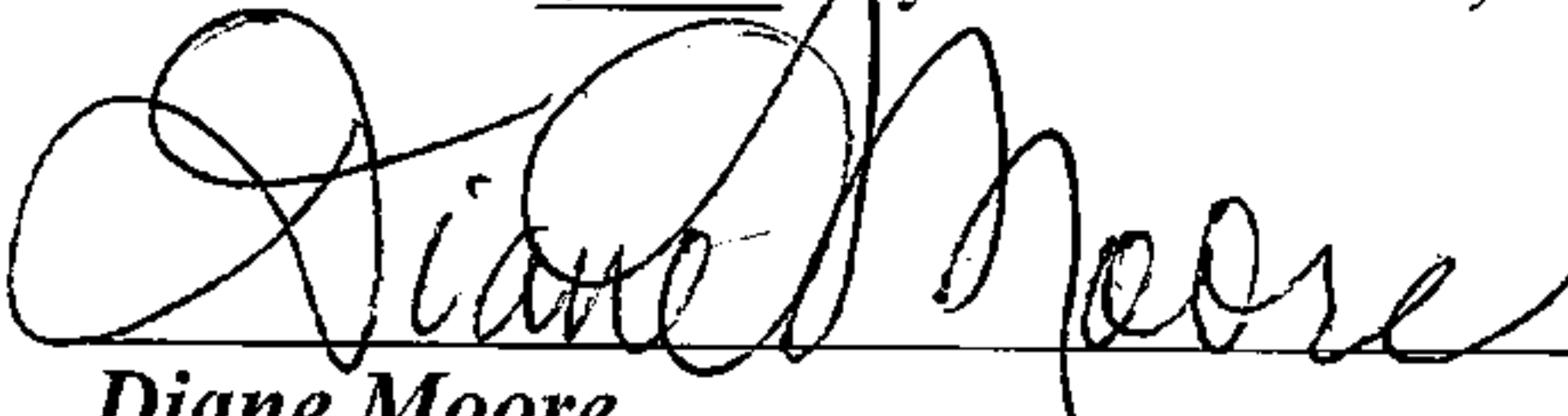

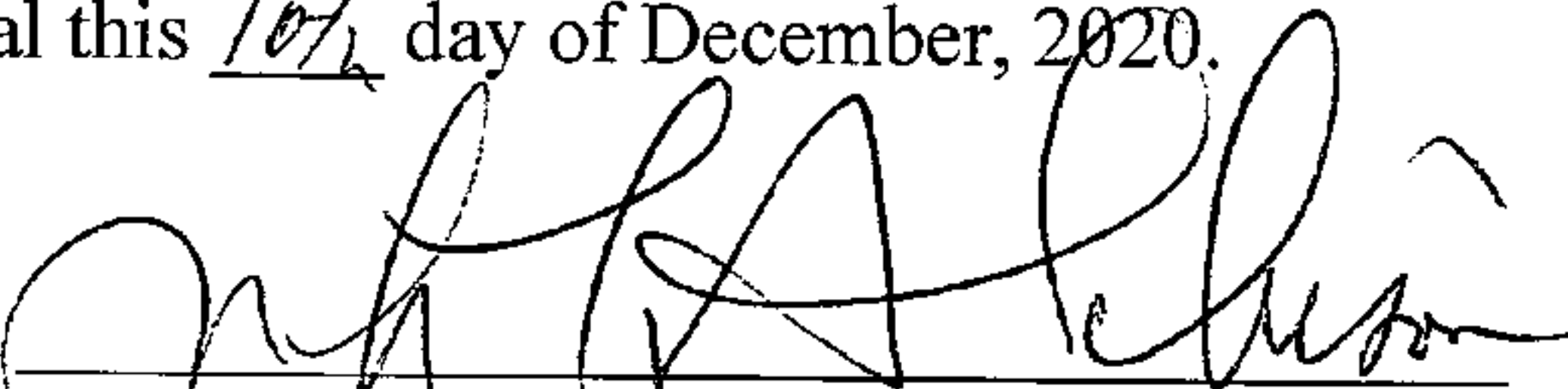

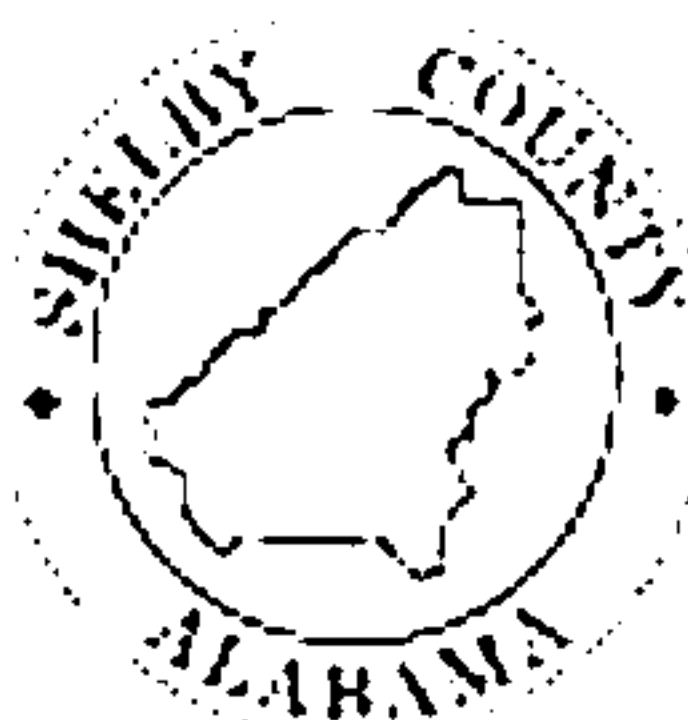
