

ARTICLES OF ORGANIZATION OF ESQUIRE AVIATION, LLC

The undersigned, for the purpose of forming a limited liability company (the "Company") pursuant to the provisions of the Alabama Limited Liability Company Act (the "Act") (Alabama Code §10-12-1, et seq.) hereby certifies as follows:

1. NAME OF COMPANY: The name of the Company is:

- 2. <u>PERIOD OF DURATION</u>: The period of duration of the Company shall be perpetual.
