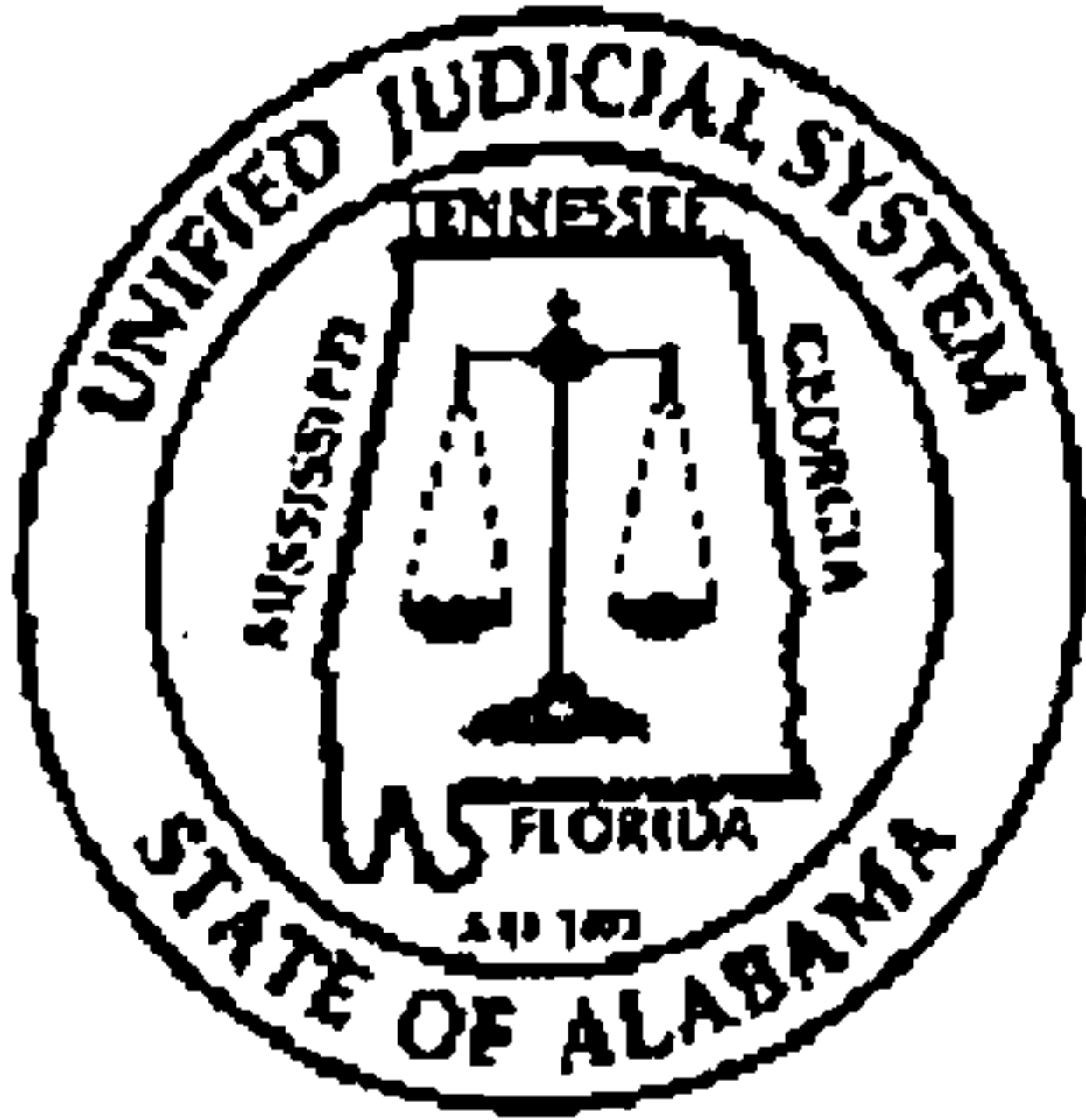

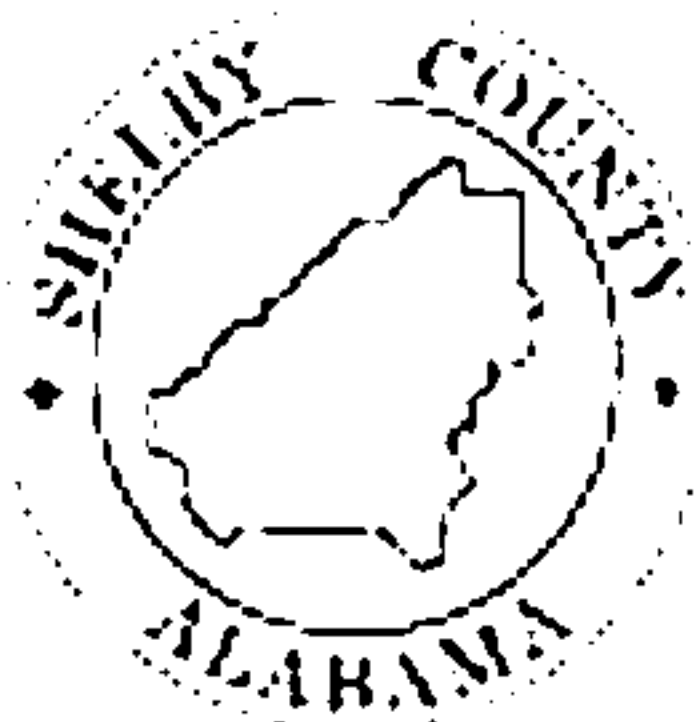
DEFAULT JUDGMENT ORDER

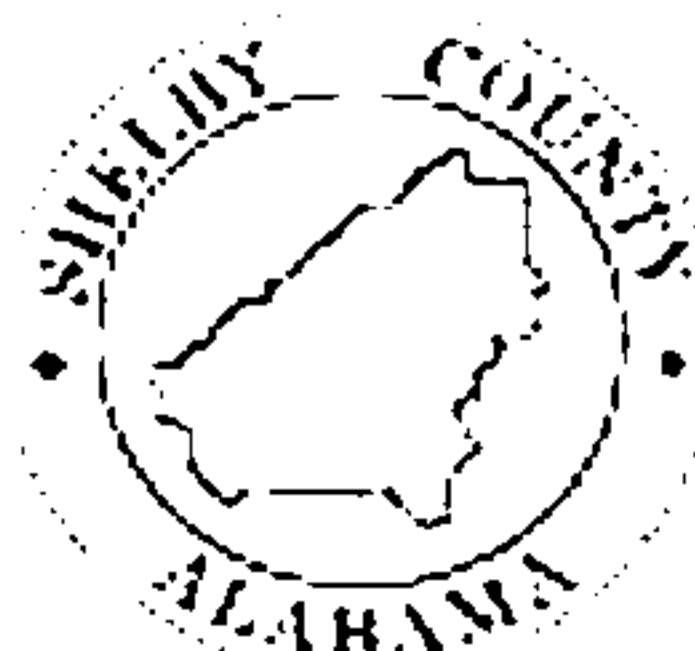
