Together with a 60' easement for ingress and egress and utilities as shown on Map Book 49, Page 52A and 52B in the Probate Office of Shelby County, Alabama.

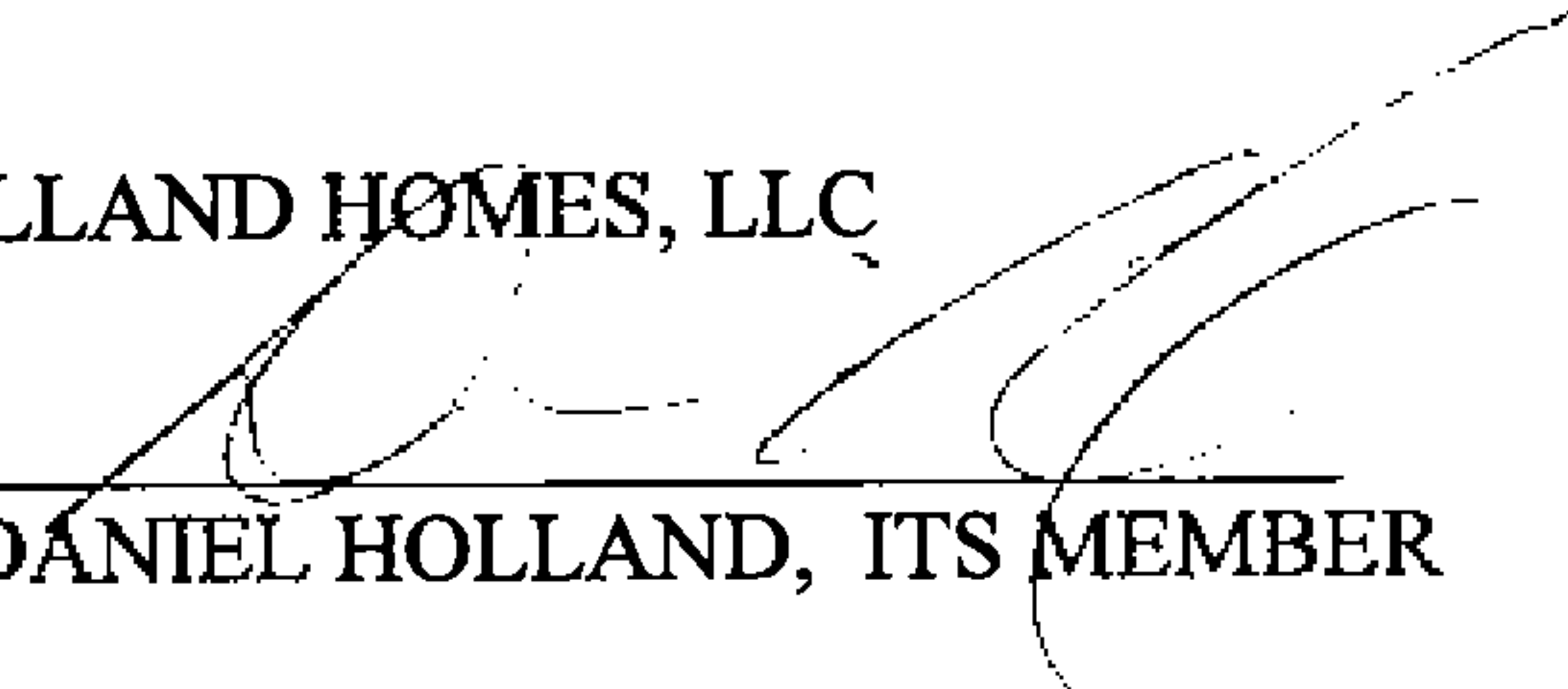
Subject to: All easements, restrictions and rights of way of record.

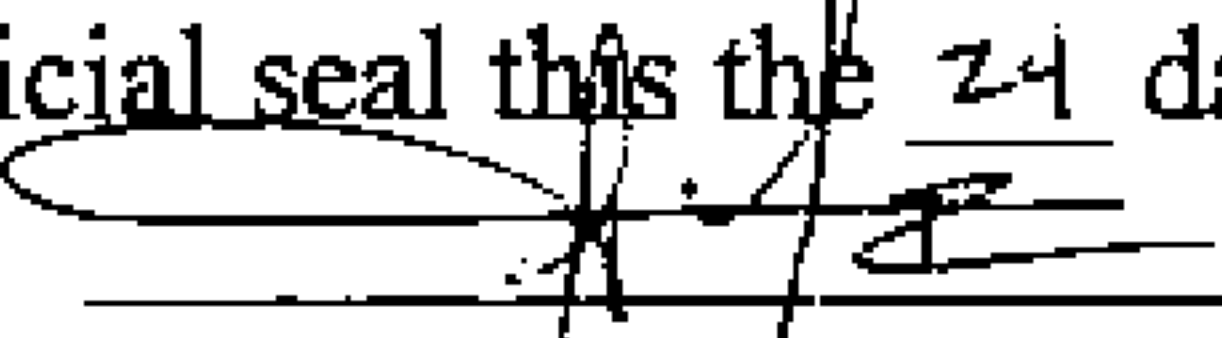
