The Association claims a lien upon property owned by Stephen & Allia Moore., situated in Shelby County, Alabama described as follows:

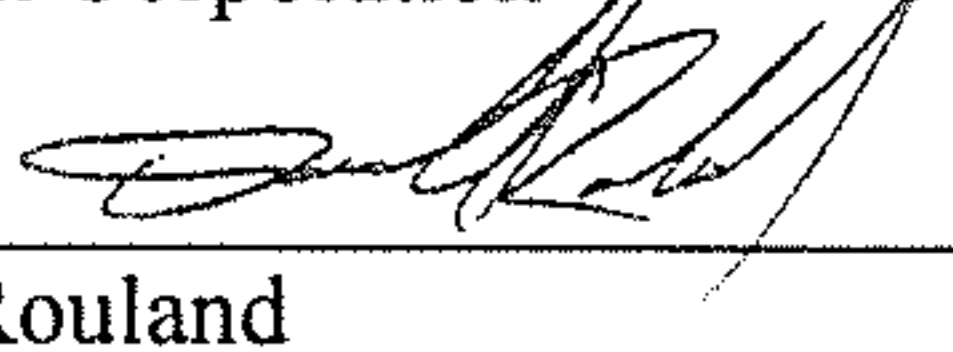

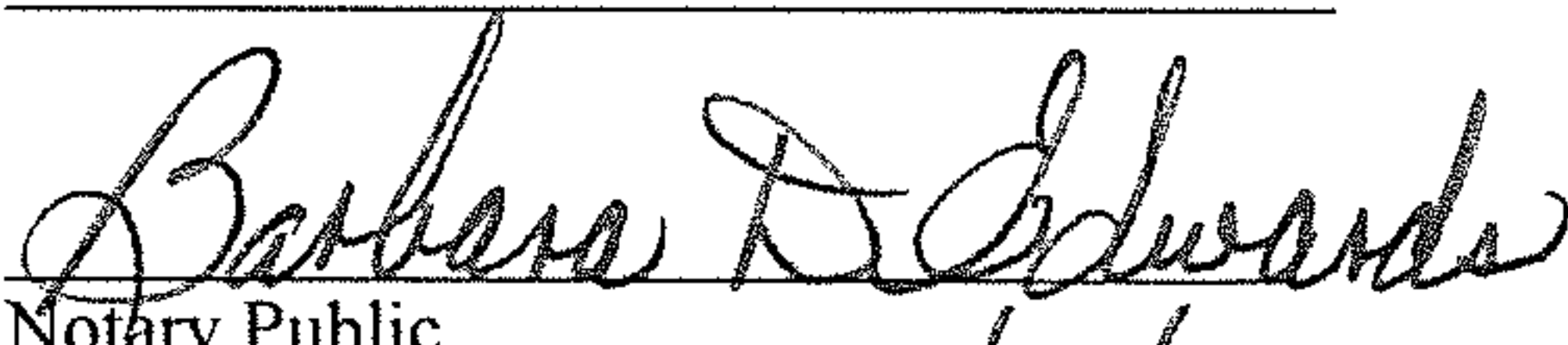
