JUANITA D. WILKES is one and the same person as JUANITA D. WATTS, the Grantee of that certain deed recorded in Instrument No. 20081002000391080.

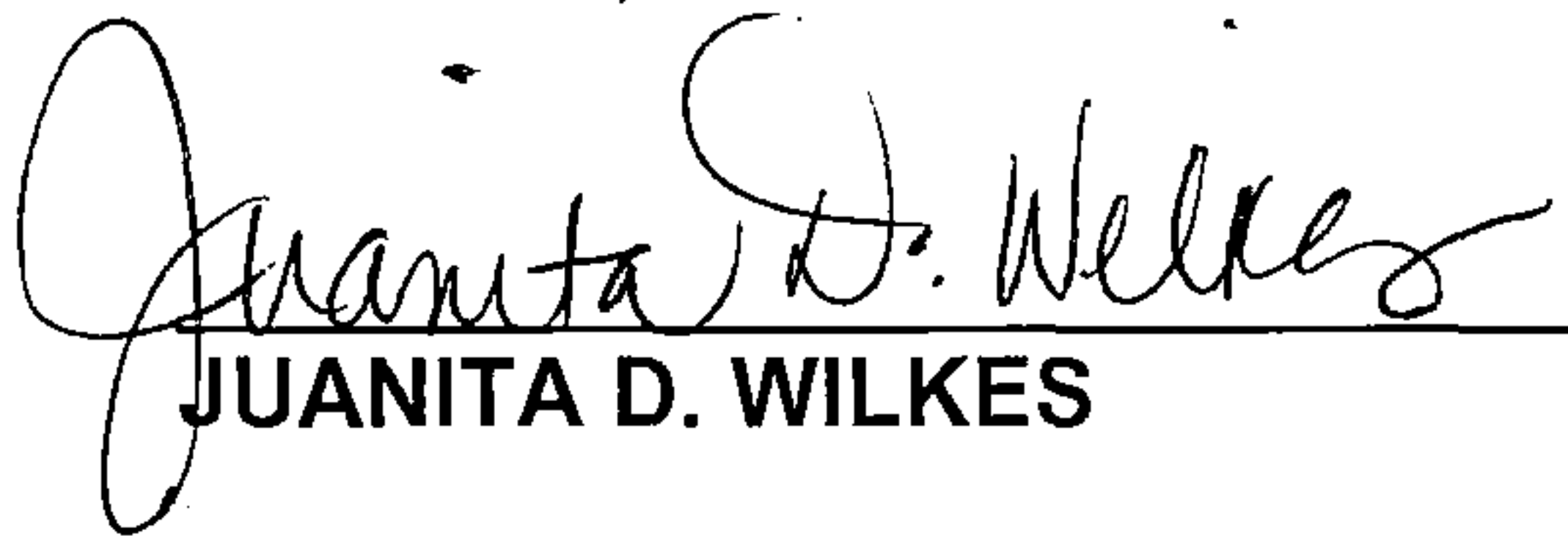
