ne Company is further granted all the rights or privileges necessary or convenient for the full enjoyment and use of said right of way for the purposes above escribed, including, without limitation, the right of ingress and egress to and from said Facilities, as applicable, the right to excavate for installation, replacement pair and removal of said Facilities, and also the right to cut, remove, and otherwise keep clear any and all structures, obstructions, or obstacles of whatever naracter, on, under, adjacent to, and above said Facilities.

he easements, rights and privileges granted hereby shall apply to, and the word "Property" as used in this instrument shall mean the real property more particularly escribed in that certain instrument recorded in <u>Instrument #20200526000207550</u>. in the Office of the Judge of Probate of the above named County.

the event it becomes necessary or desirable for the Company from time to time to move any of the Facilities in connection with the construction or improvement any public road or highway in proximity to the Facilities, Grantors hereby grant to the Company the right to relocate the Facilities and, as to such relocated acilities, to exercise the rights granted above; provided, however, the Company shall not relocate said Facilities on the Property at a distance greater than ten fee 10') outside the boundary of the right of way of any such public road or highway as established or re-established from time to time. This grant and agreement shall be binding upon and shall inure to the benefit of Grantors, the Company and each of their respective heirs, personal representatives, successors and assigns and the words "Company" and "Grantors" as used in this instrument shall be deemed to include the heirs, personal representatives, successors and assigns of suclarties.
