(hereinafter known KNOW ALL MEN BY THESE PRESENTS, That the undersigned_____ BRAD STAMPS, a single man as "Grantors", whether one or more) for and in consideration of One and No/100 Dollar (\$1.00) and other good and valuable consideration paid to Grantors in hand by Alabama Power Company, a corporation, the receipt and sufficiency of which are hereby acknowledged, do hereby grant to said Alabama Power Company, its successors and assigns (hereinalter the "Company"), the following easements, rights, and privileges

The right to trim and cut and keep trimmed and cut all dead, weak, leaning or dangerous trees or limbs that, in the opinion of the Company, may now or hereafter endanger, interfere with or fall upon any of the Company's electric power and/or communication lines, poles, towers or other facilities (collectively, the "Facilities") that may be now or hereafter located adjacent to the Property described below, along a route selected by the Company, as determined by the location(s) in which the Company's Facilities are to be installed, and also the right to cut, remove, and otherwise keep clear any and all trees, undergrowth, structures, obstructions, or obstacles of whatever character on such Property within fifteen feel (15) on all sides of Company Facilities. The Company is further granted the right of ingress and egress to and from said Property for the above described purposes.

The right to implant, install and maintain anchor(s) on and under the Property described below, and to construct, extend and maintain guy wires from such anchor(s) on, over, under, and across the Property to structures now or hereafter erected adjacent to such Property (collectively, the "Guy Wire Facilities") along said route selected by the Company as determined by the location(s) in which the Company's structures are to be installed; and also the right to trim and cut and keep trimmed and cut all dead, weak, leaning or dangerous trees or limbs that, in the sole opinion of the Company, may now or hereafter endanger, interfere with or fall upon such Guy Wire Facilities. Grantor hereby grants to the Company all easements, rights and privileges necessary or convenient for the full enjoyment and use thereof, including without limitation the right of ingress and egress to and from the Guy Wire Facilities and the right to excavate for installation, replacement, repair and removal thereof, and also the right to cut, remove and otherwise keep clear any and all structures, obstructions or obstacles of whatever character, on, under or above said Guy Wire Facilities.

The easements, rights and privileges granted hereby shall apply to, and the word "Property" as used in this instrument shall mean the real property more particularly described in that certain instrument recorded in ______ INSTRUMENT #19990922000395771 ___, in the Office of the Judge of Probate of the above named County.
