

# ARTICLES OF ORGANIZATION

OF

DUCK COVE, L.L.C.

Pursuant to the Provisions of the Code of Alabama, Title 10A, Chapter 5 Article 1.01, et. Seq., the undersigned hereby adopts the following limited liability company Articles of Organization:

## ARTICLE I

The name of the limited liability company is: DUCK COVE, L.L.C. (hereinafter referred to as the "Company").

## ARTICLE II

The period of duration for the Company is perpetual, beginning from the date these Articles of Organization are filed in the Office of the Judge of Probate of the county in which the initial registered office of the Company is located.

## ARTICLE III

The purpose or purposes for which the Company is organized is the transaction of any and all lawful business for which limited liability companies may be organized under the Alabama Limited Liability Company Act.

## ARTICLE IV

The company shall be managed by its members as provided in the Operating Agreement of the Company.

## ARTICLE VII

The initial members of the Company shall have no right to admit additional members except in accordance with the Operating Agreement of the Company, as amended from time to time.

## ARTICLE VIII

The cessation of membership of one or more members will result in dissolution of the Company except when there is at least one remaining member and all remaining members consent in writing to continue the legal existence and business of the Company within 90 days after such cessation of membership in accordance with the Operating Agreement of the Company.


## ARTICLE IX


