SUBJECT TO ALL MATTERS OF RECORD


\$175,777.00 of the purchase price recited above has been paid from the proceeds of a mortgage loan closed simultaneously herewith.

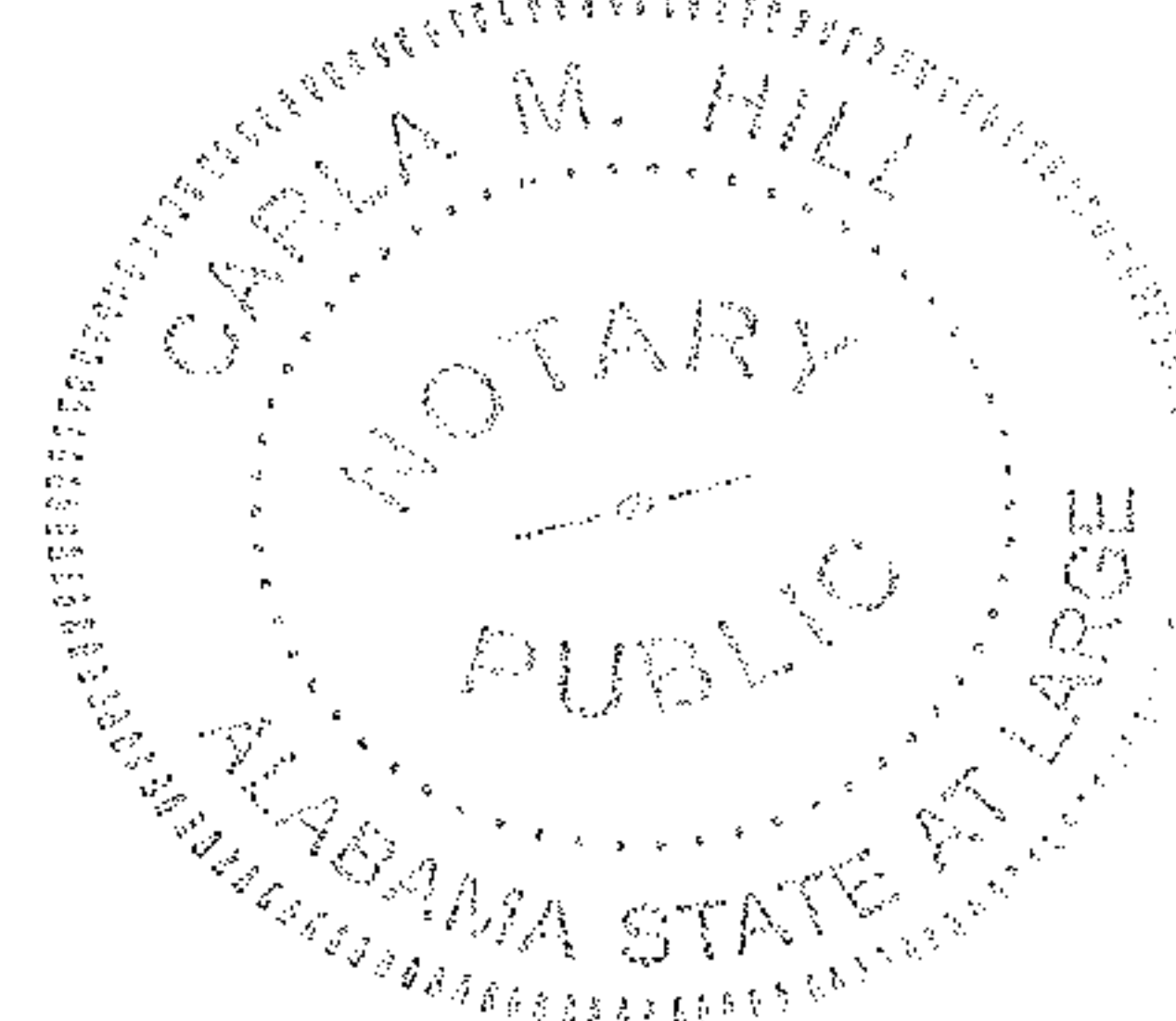
