WARRANTY DEED WITH JOINT RIGHT OF SURVIVORSHIP

KNOW ALL MEN BY THESE PRESENTS,

On this January 4, 2021, That for and in consideration of **FOUR HUNDRED FIFTEEN THOUSAND AND NO/100 (\$415,000.00) DOLLARS**, and other good and valuable consideration, this day in hand paid to the undersigned **RICK ANTHONY PETTINATO, JR. and JORDAN M. PETTINATO, husband and wife**, (herein referred to as "Grantors"), in hand paid by the Grantees herein, the receipt whereof is hereby acknowledged, the Grantors do hereby give, grant, bargain, sell and convey unto the Grantees,

DAVID EMORY CUNNINGHAM and CAROLINA ZAMORA VALVERDE, (herein referred to as "Grantees"), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, all of the Grantors' interest in the following-described Real Estate situated in, **SHELBY COUNTY, ALABAMA**, to wit:

Lot 217, according to the Survey of Ninth Addition to Riverchase Country Club, as recorded in Map Book 8, Page 46 A & B, in the Probate Office of Shelby County, Alabama.

Subject to:

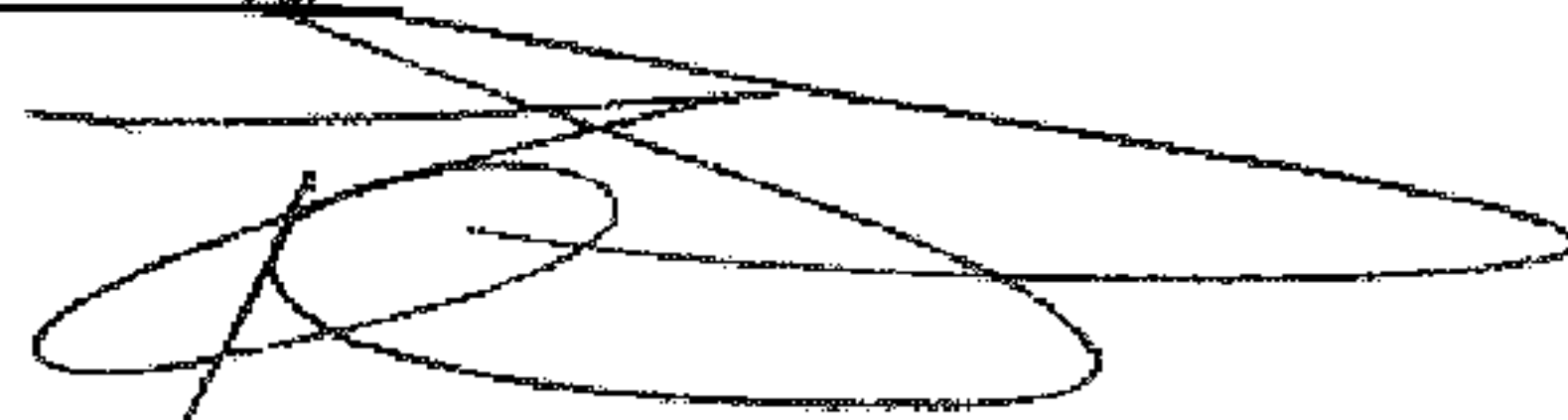
1. General and special taxes or assessments for the year 2021 and subsequent years not yet due and payable.

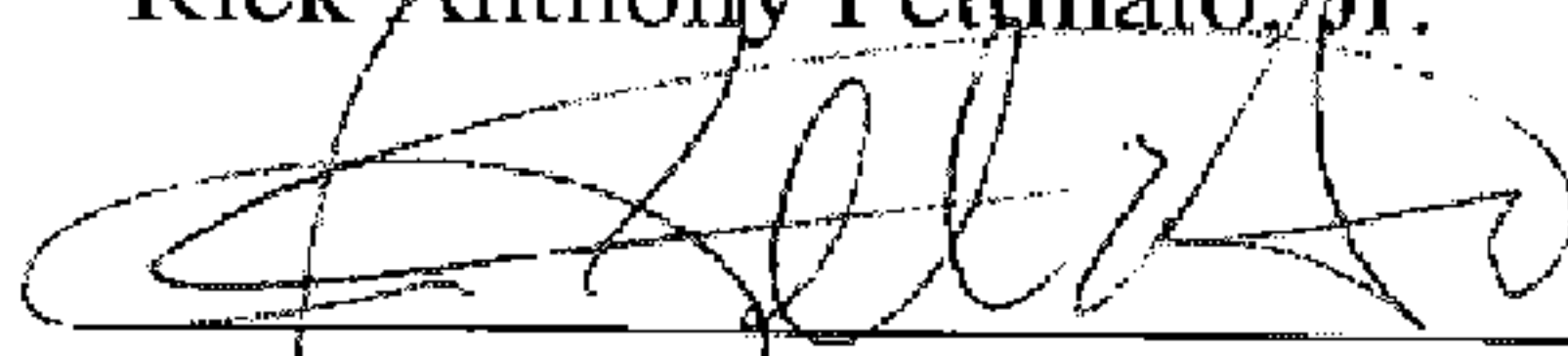

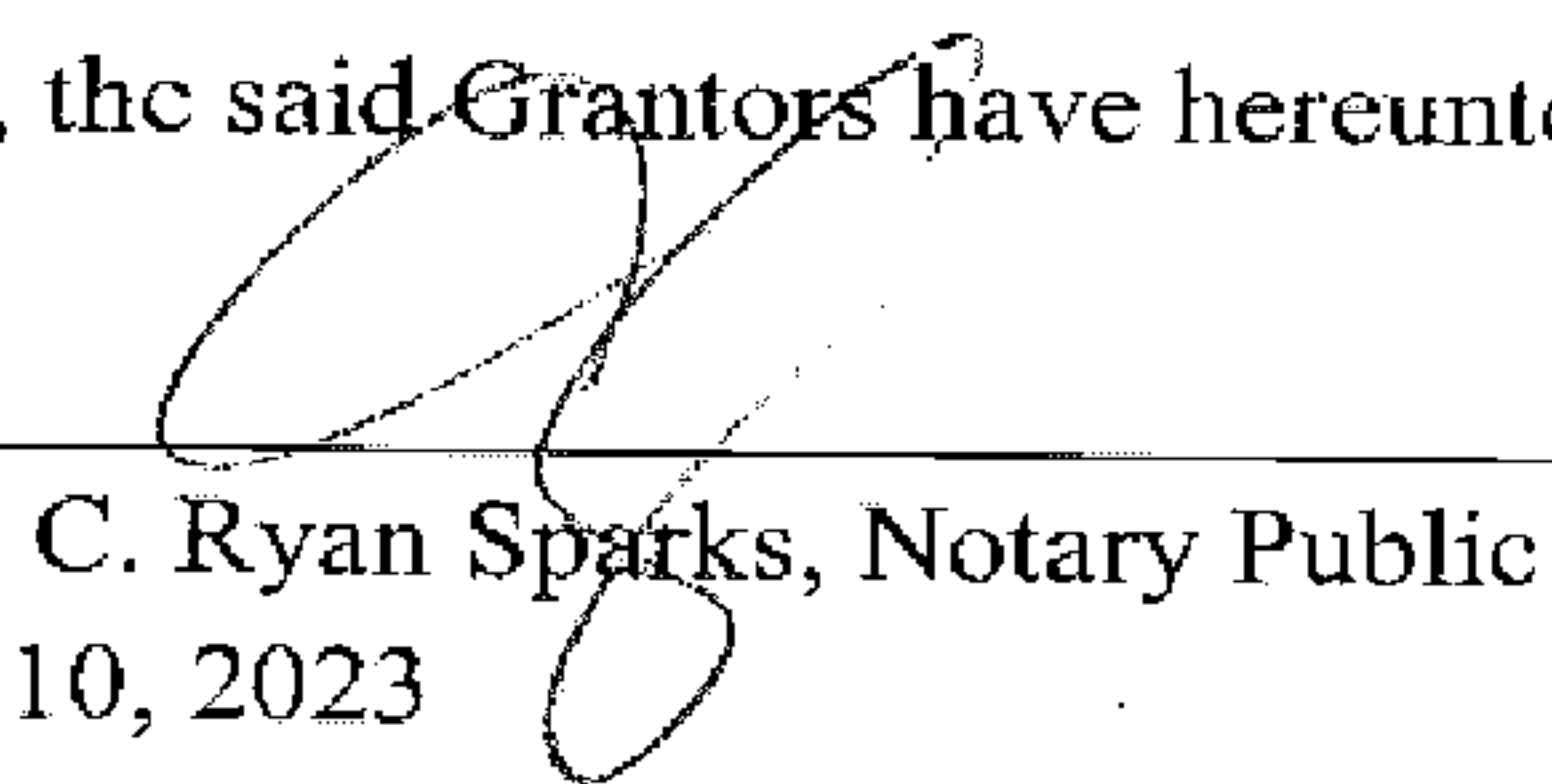

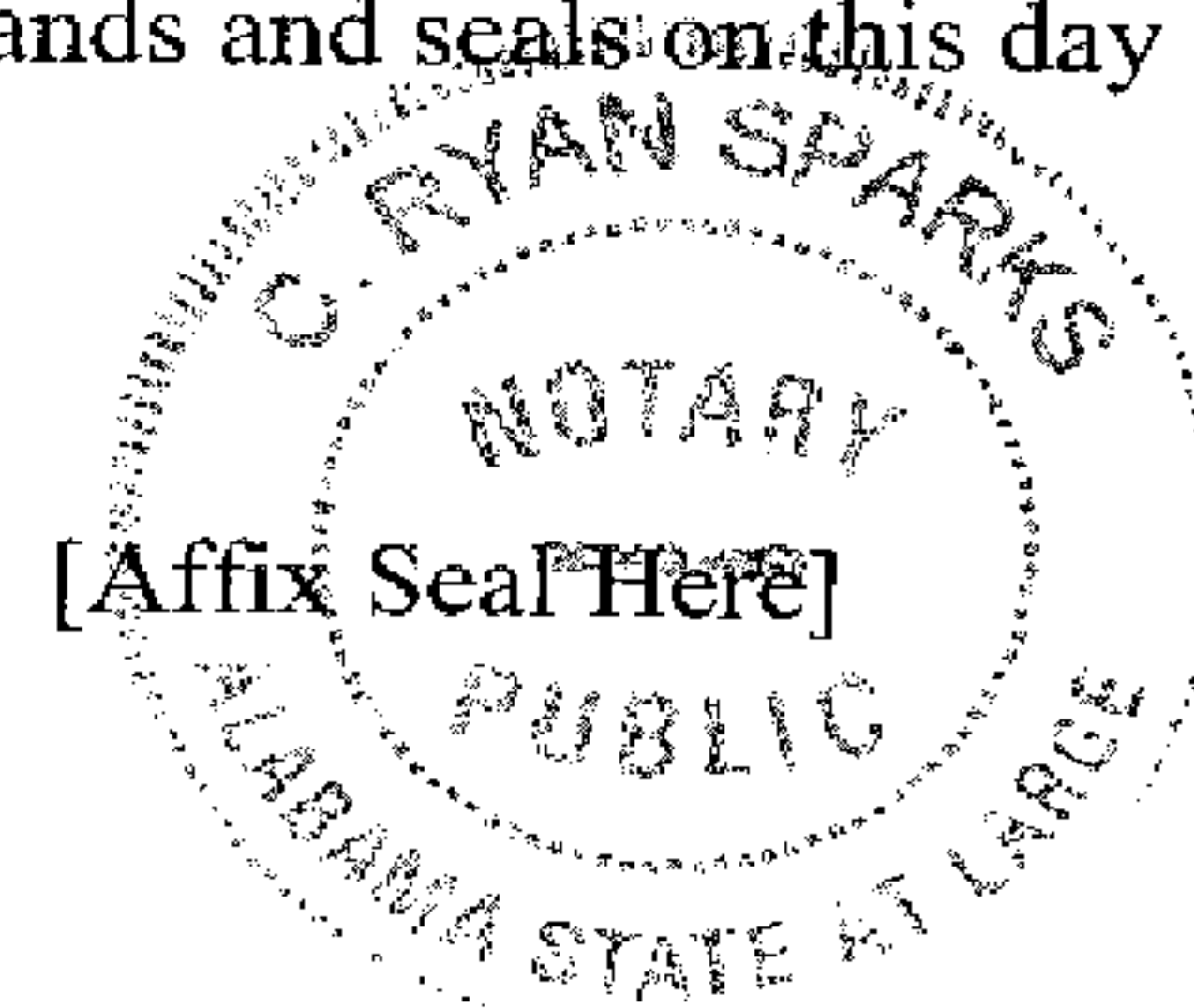
