\$161,250.00 of the purchase price was obtained by a purchase money mortgage filed simultaneously herewith



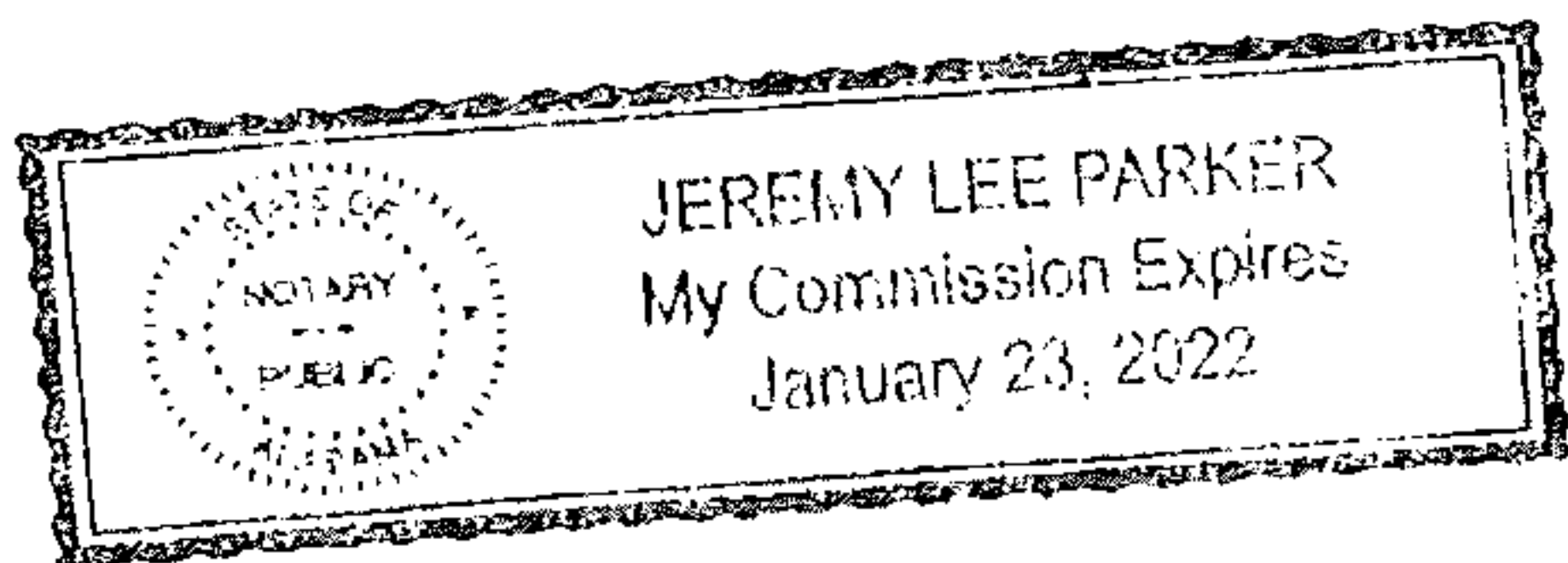

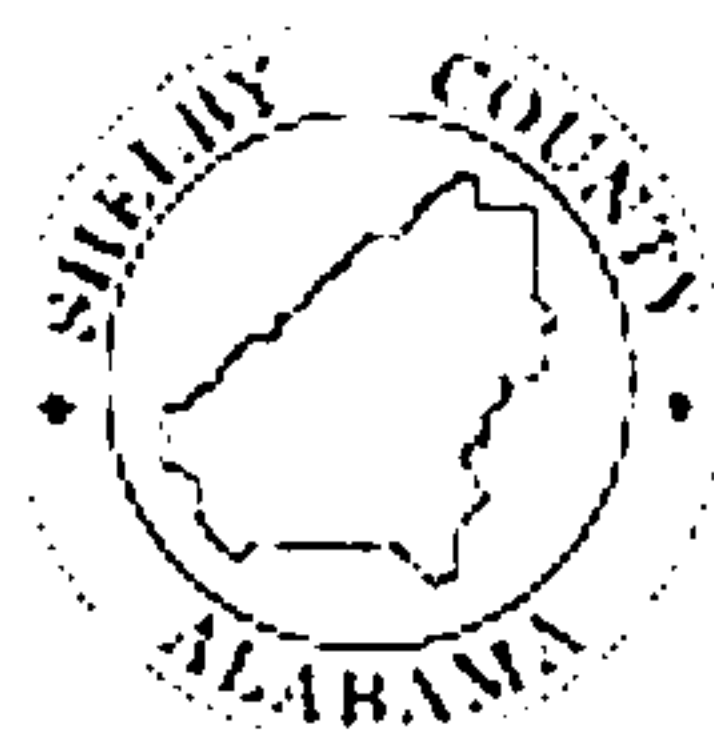
