KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration of **Four Hundred Seventy-Five Thousand Two Hundred Thirty-Seven and 00/100 (\$475,237.00)**, and other good and valuable consideration, this day in hand paid to the undersigned **Cornerstone Building, LLC, an Alabama limited liability company** (hereinafter referred to as GRANTOR), in hand paid by the GRANTEES herein, the receipt whereof is hereby acknowledged, the GRANTOR does hereby give, grant, bargain, sell and convey unto the GRANTEES, **Harrison Grey Domingue and Samantha Leah Domingue**, (hereinafter referred to as GRANTEES), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described Real Estate, lying and being in the County of **Shelby**, State of Alabama, to-wit:

Lot 22-62, according to the Map of Highland Lakes, 22nd Sector, Phase II, an Eddleman Community, as recorded in Map Book 36, Page 94 A, B and C, in the Probate Office of Shelby County, Alabama.

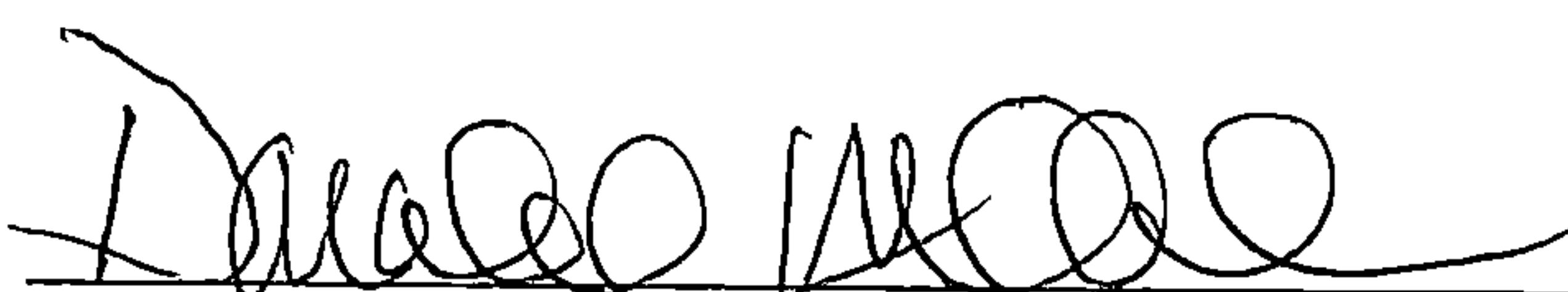
