That in consideration of ONE HUNDRED FIFTY SEVEN THOUSAND and 00/100 Dollars (\$157,000.00) to the undersigned GRANTORS in hand paid by the GRANTEE herein, the receipt of which is hereby acknowledged, Jimmy Jimenez and Wendy Jimenez, husband and wife, and Jaime Jimenez, a single individual, (herein referred to as GRANTORS), do hereby grant, bargain, sell and convey unto Tenidra Harris, a single individual (herein referred to as GRANTEE), the following described real estate situated in Shelby County, Alabama, to-wit:



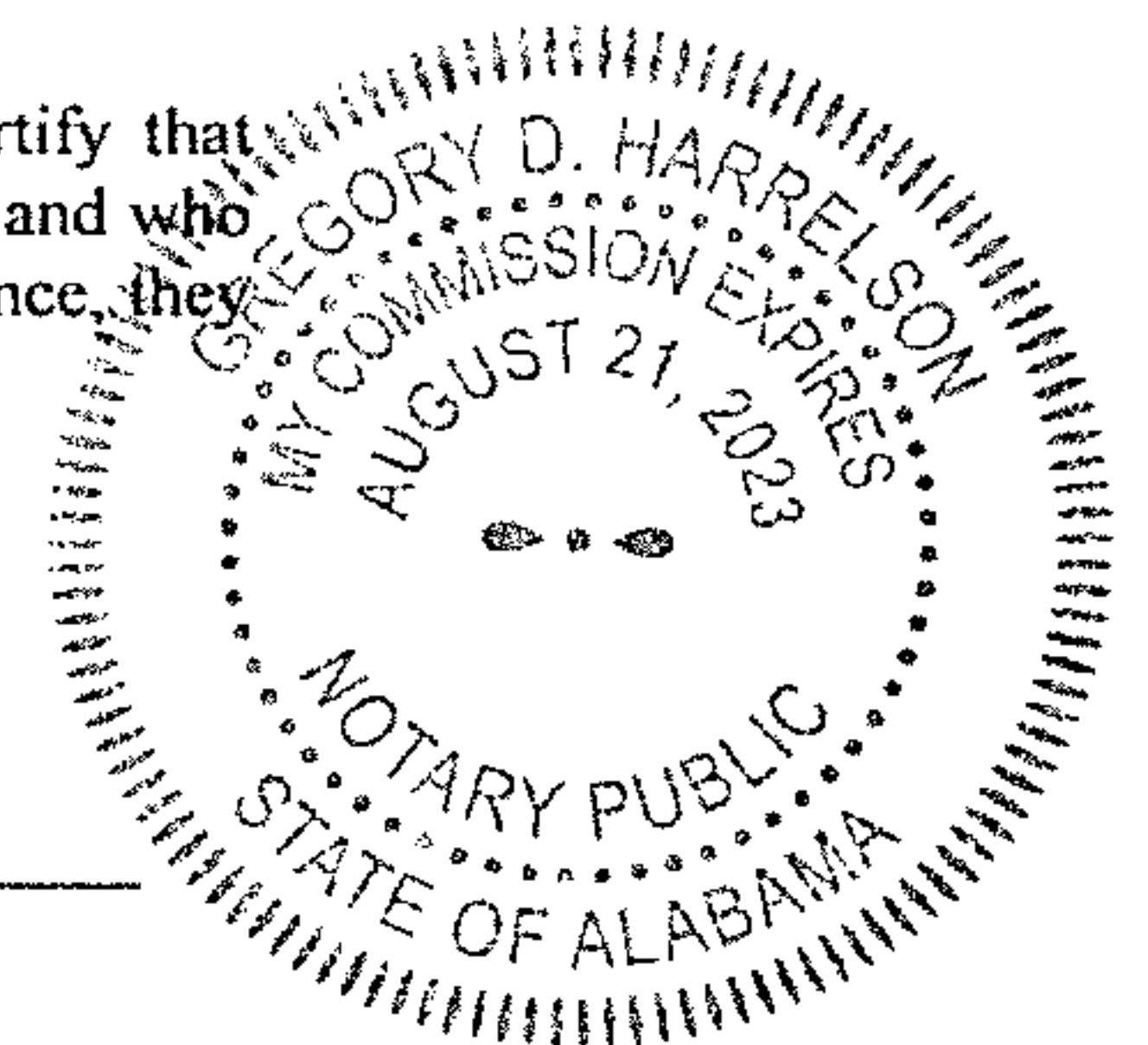
