Know All Men by These Presents: That in consideration of **ONE HUNDRED EIGHTY-NINE THOUSAND EIGHT HUNDRED and 00/100 Dollars (\$189,800.00)**, to the undersigned Grantors, in hand paid by the Grantees herein, the receipt where is acknowledged, we, **JOSEPH B. BODIFORD and LOIS ANN BODIFORD, husband and wife** (herein referred to as Grantors) grant, bargain, sell and convey unto **LINDA B. MOSS and JOHN L. MOSS** (herein referred to as Grantees), the following described real estate, situated in **SHELBY** County, Alabama, to-wit:



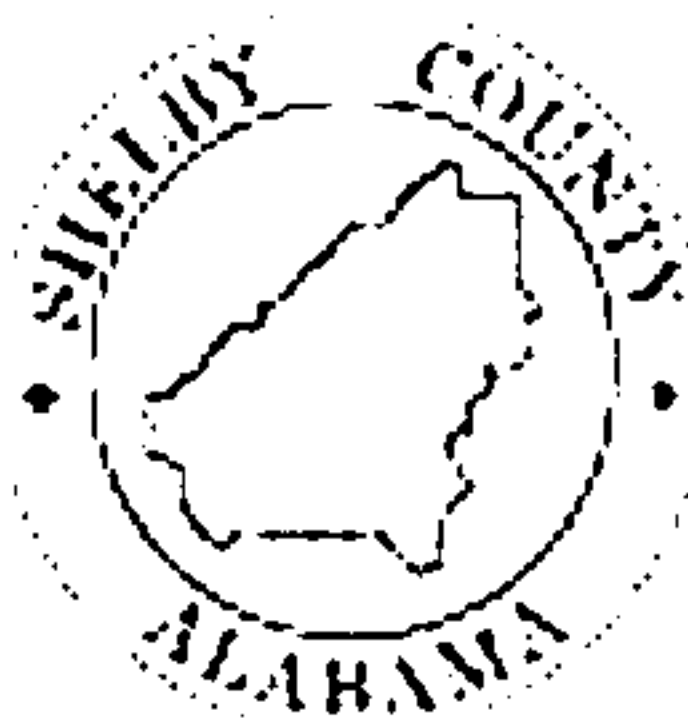
