Know All Men by These Presents: That in consideration of **Six Hundred Twenty Thousand Six Hundred and 00/100 Dollars (\$620,600.00)**, to the undersigned Grantor, in hand paid by the Grantees herein, the receipt where is acknowledged, **DONOVAN BUILDERS, LLC** (herein referred to as Grantor), grant, bargain, sell and convey unto **MARCOS N. DINIZ and JOSELIA P. DINIZ** (herein referred to as Grantees), the following described real estate, situated in **SHELBY** County, Alabama, to-wit:

Lot 13B, according to a Resurvey of Lot 13 of Creekwater Phase III, as recorded in Map Book 52, Page 38, in the Probate Office of Shelby County, Alabama.

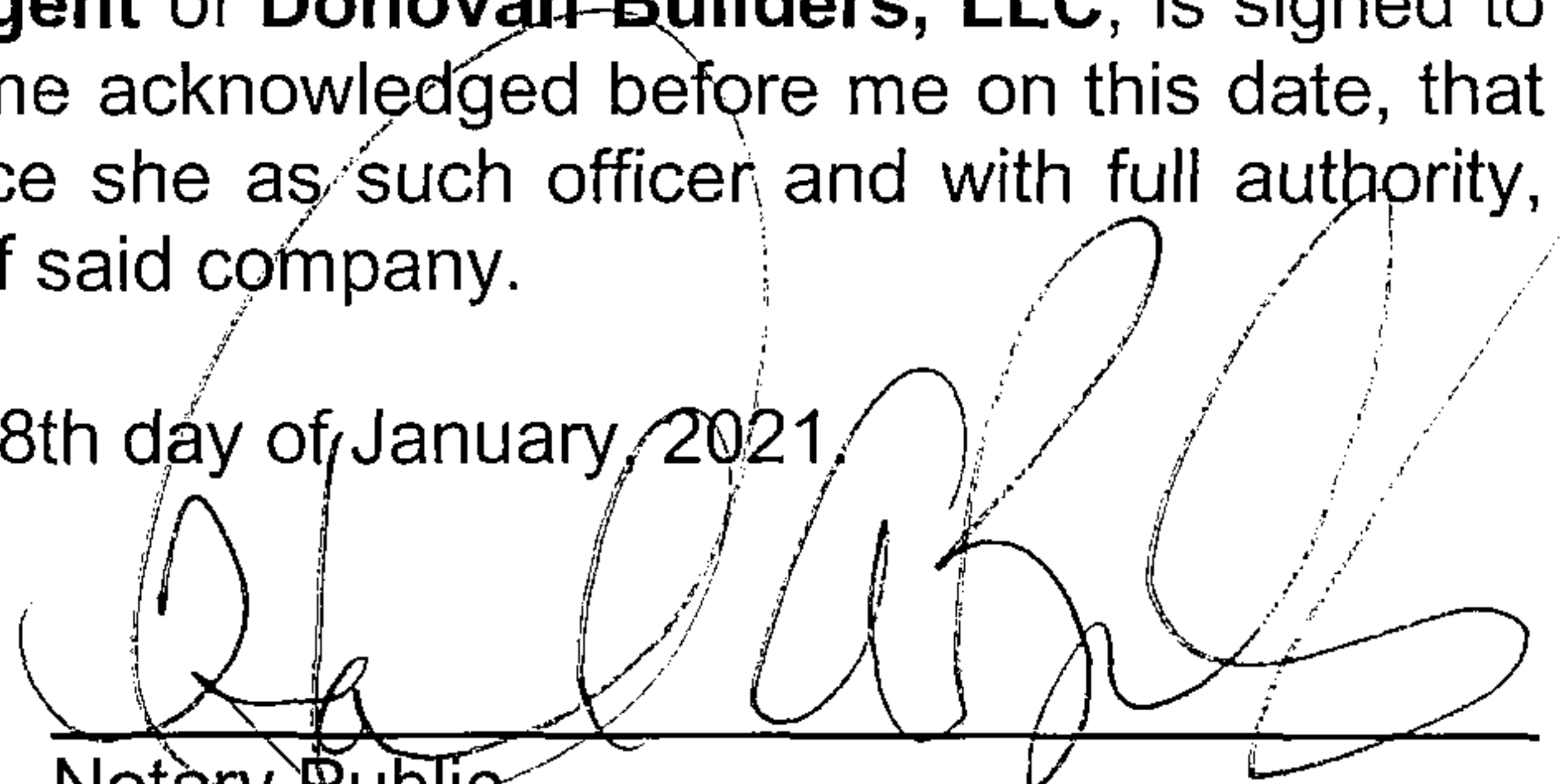
