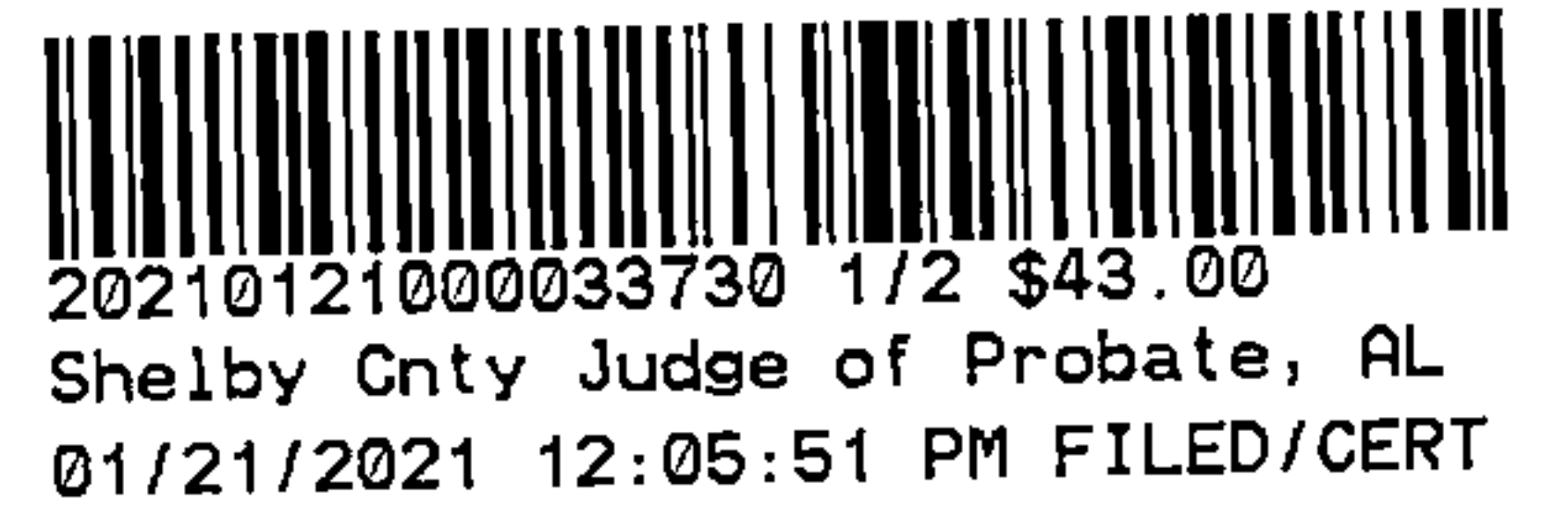

NOW THEREFORE, BE IT RESOLVED, by the Board of Directors of Alabama Municipal Insurance Corporation,


