### SPECIFIC POWER OF ATTORNEY

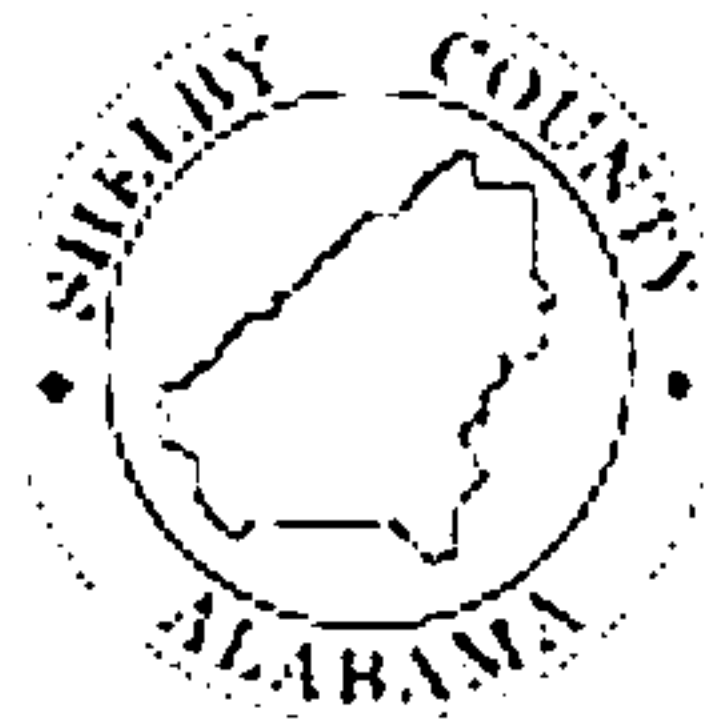
