The said property, for which annexation into Chelsea is requested in this petition, does not lie within the corporate limits of any other municipality.

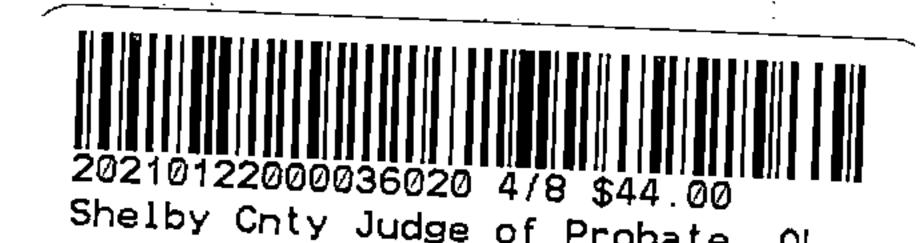

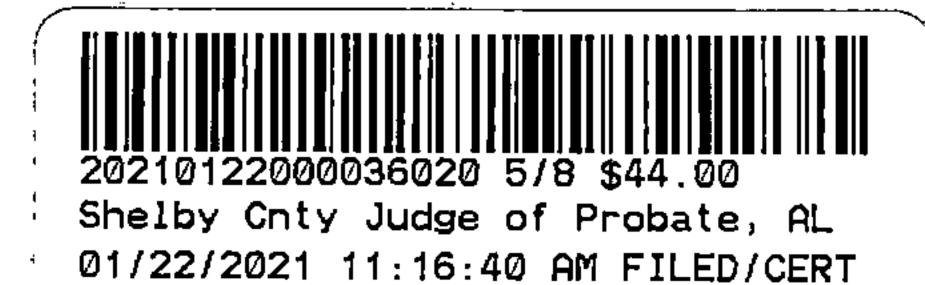
