KNOW ALL MEN BY THESE PRESENTS, That in consideration FIVE THOUSAND AND NO/00 DOLLARS (\$5,000.00), and other good and valuable considerations to the undersigned grantor (whether one or more), in hand paid by grantee herein, the receipt whereof is acknowledged, I or we, **Helen Bush, a single woman** (herein referred to as **Grantor**) grant, bargain, sell and convey unto **David W. Hasenbein and Rhoda B. Hasenbein** (herein referred to as **Grantees**), the following described real estate, situated in: SHELBY County, Alabama, to-wit:

*Lot 4, according to the Survey of Helen Bush Family Subdivision, as recorded in Map Book 53, Page 30, in the Probate Office of Shelby County, Alabama.*

**SUBJECT TO:**

1. Ad valorem taxes due and payable October 1, 2021.
2. Easements, restrictions, rights of way, and permits of record.
3. Property constitutes no part of the homestead of the Grantor herein or his spouse.




