POWER OF ATTORNEY

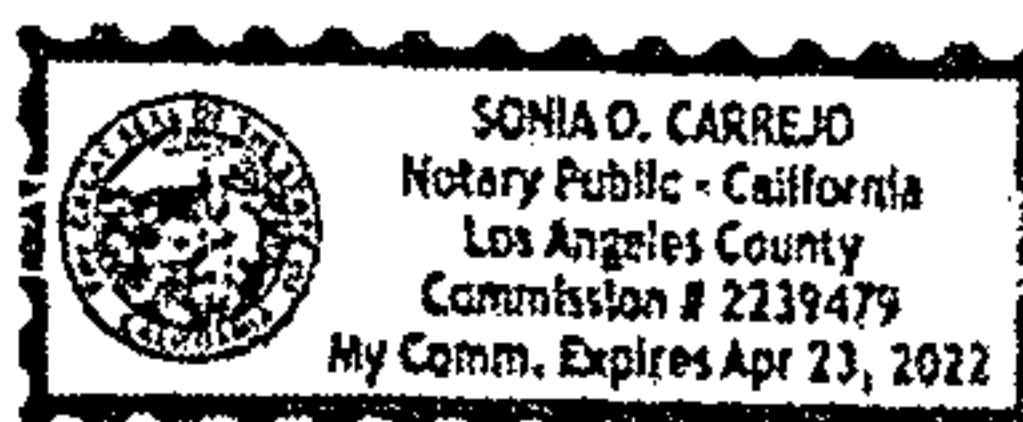

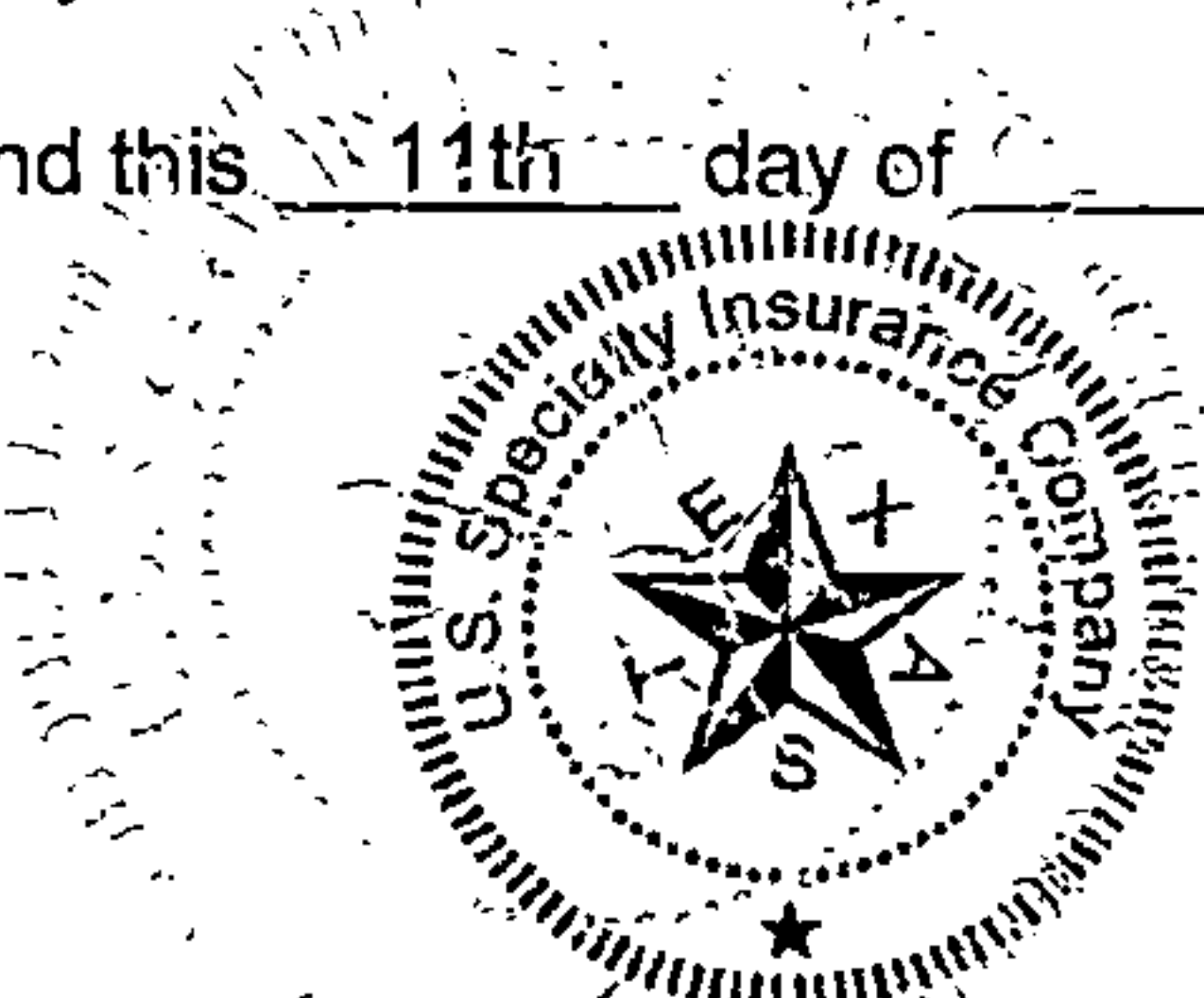
