Know All Men by These Presents: That in consideration of **Five Hundred Eleven Thousand Nine Hundred and 00/100 Dollars (\$511,900.00)**, to the undersigned Grantor, in hand paid by the Grantees herein, the receipt where is acknowledged, **DONOVAN BUILDERS, LLC** (herein referred to as Grantor), grant, bargain, sell and convey unto **PHILLIP DURAL GUY, JR. and LEE ANNE FULLER GUY** (herein referred to as Grantees), the following described real estate, situated in **SHELBY** County, Alabama, to-wit:

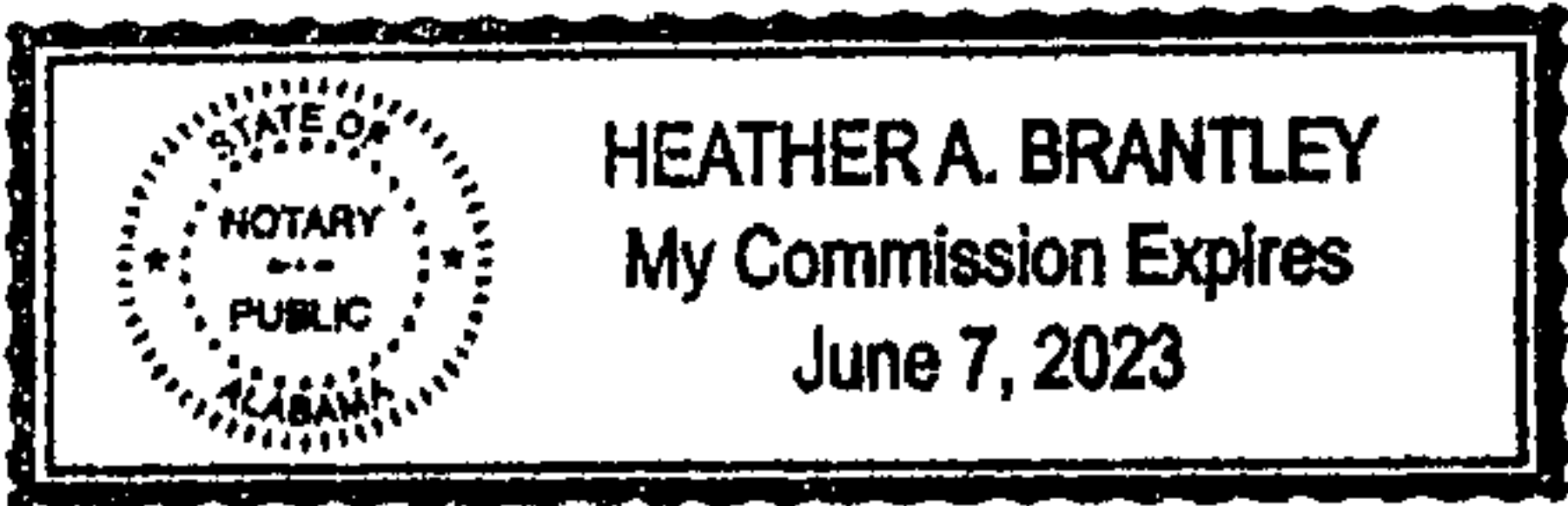
