The Association claims a lien upon property owned by **Larry & Mary Coleman** situated in Shelby County, Alabama described as follows:

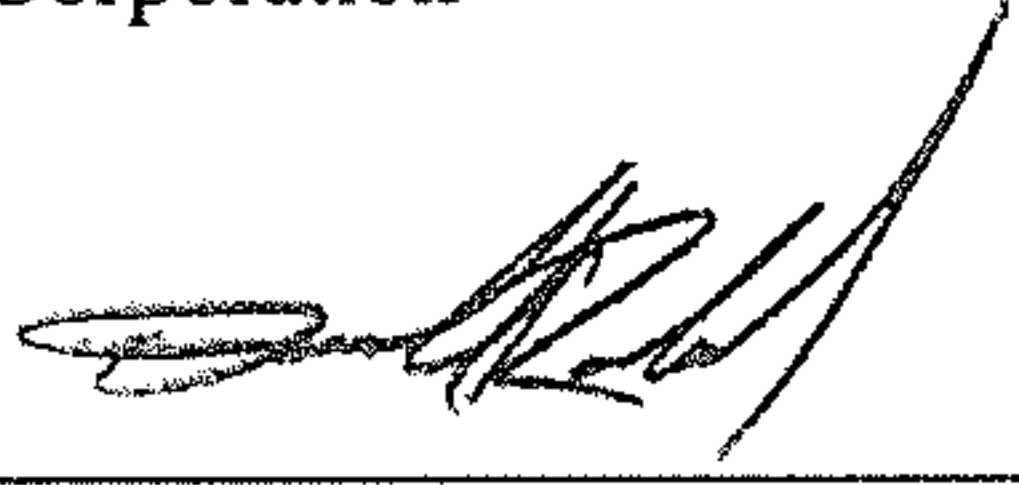

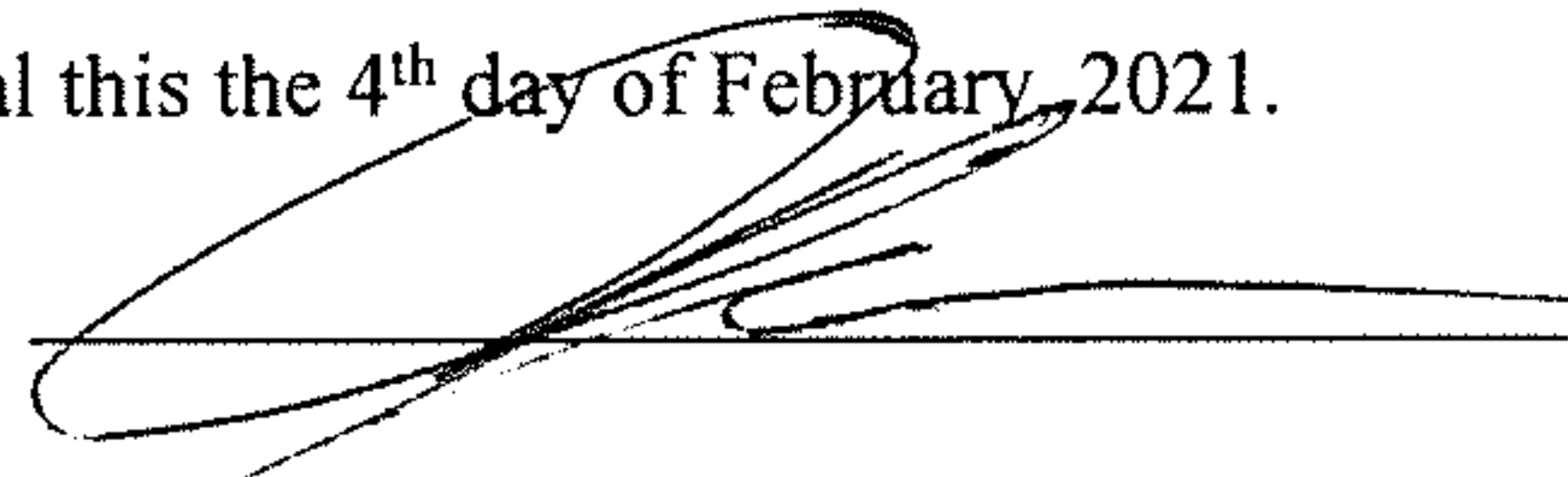
