The Association claims a lien upon property owned by **Phillip & Tara Thomas** situated in Shelby County, Alabama described as follows:

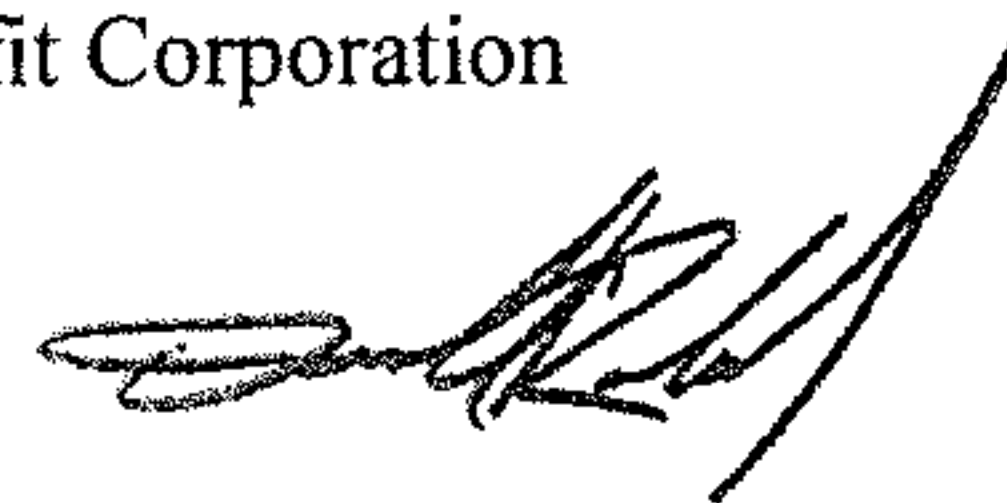
