
## QUITCLAIM DEED

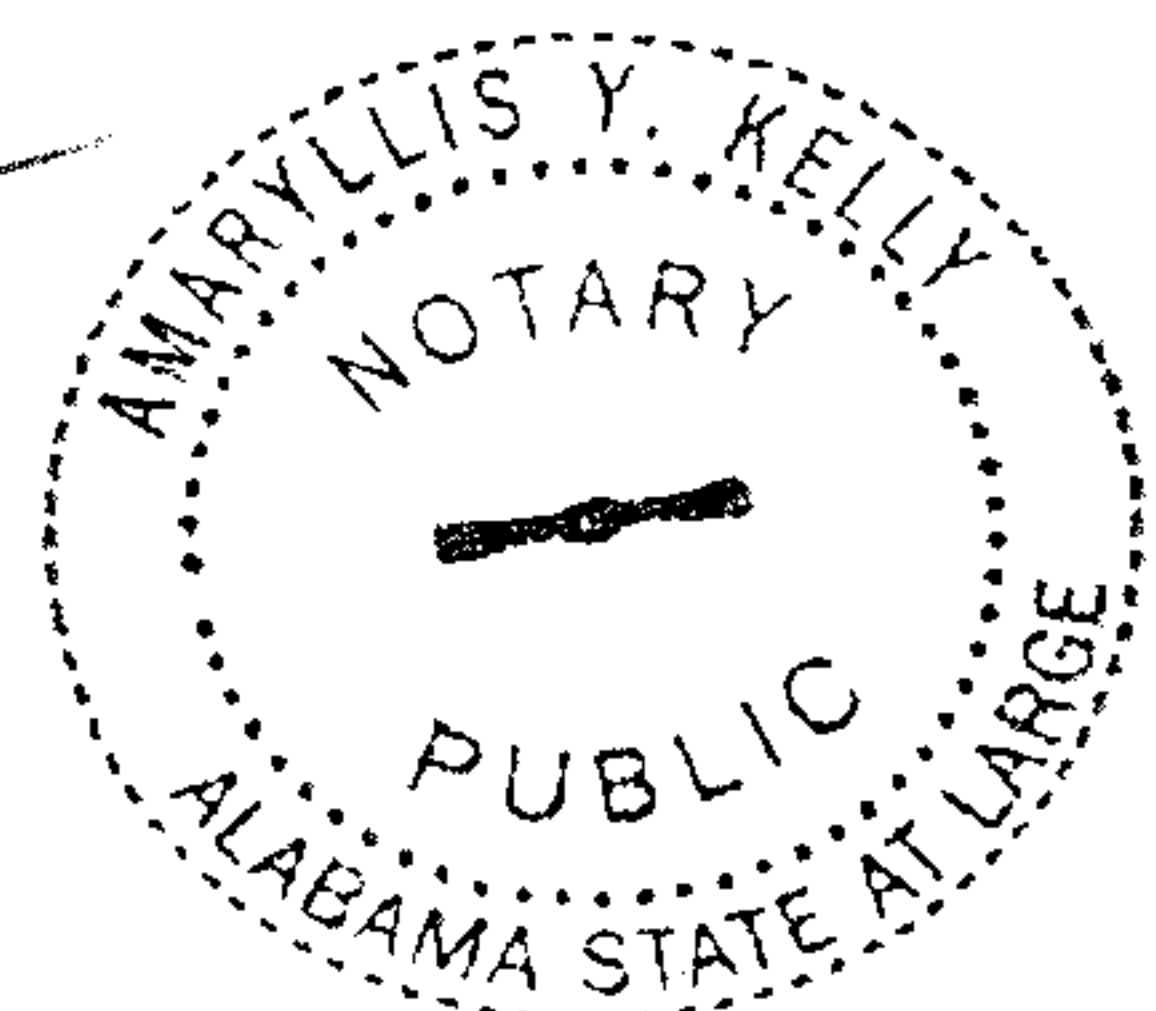
