That in consideration of **Three Hundred Thirty-Nine Thousand Dollars and No/100 Dollars (\$339,000.00)** to the undersigned grantor(s) (whether one or more); in hand paid by the grantee(s) herein, the receipt and sufficiency of which is hereby acknowledged, I or we, **Philip Poole and Shellyn Poole, Husband and Wife** (herein referred to as grantor(s), whether one or more), grant, bargain, sell and convey to **Brenden C. Shoults and Sarah C. Shoults**, hereinafter referred to as grantee(s), whether one or more), the following described real estate situated in Shelby County, Alabama to-wit:






