KNOW ALL MEN BY THESE PRESENTS:

THAT IN CONSIDERATION OF **Two Hundred Seventy-Eight Thousand Nine Hundred Dollars and NO/100 (\$278,900.00)** to the undersigned grantors, in hand paid by the Grantees herein, the receipt whereof is acknowledged, we, **Matthew Hall and Stephanie Hall, husband and wife**, (herein referred to as **Grantors**), grant, sell, bargain and convey unto, **Michael Trahan and Jessica Siniard** (herein referred to as **Grantees** whether one or more), for and during their joint lives as joint tenants with rights of survivorship and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder or right of reversion, the following described real estate, situated in Shelby County, Alabama to wit:

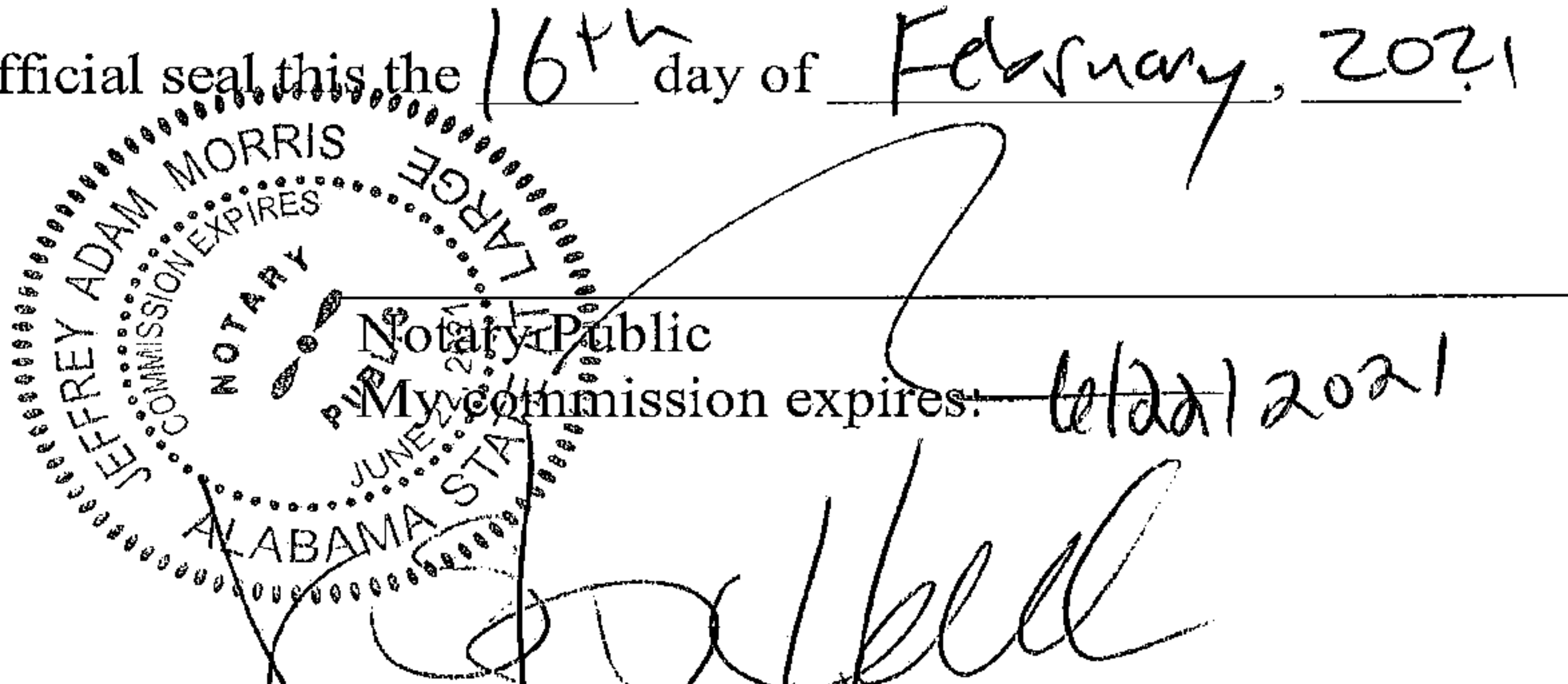

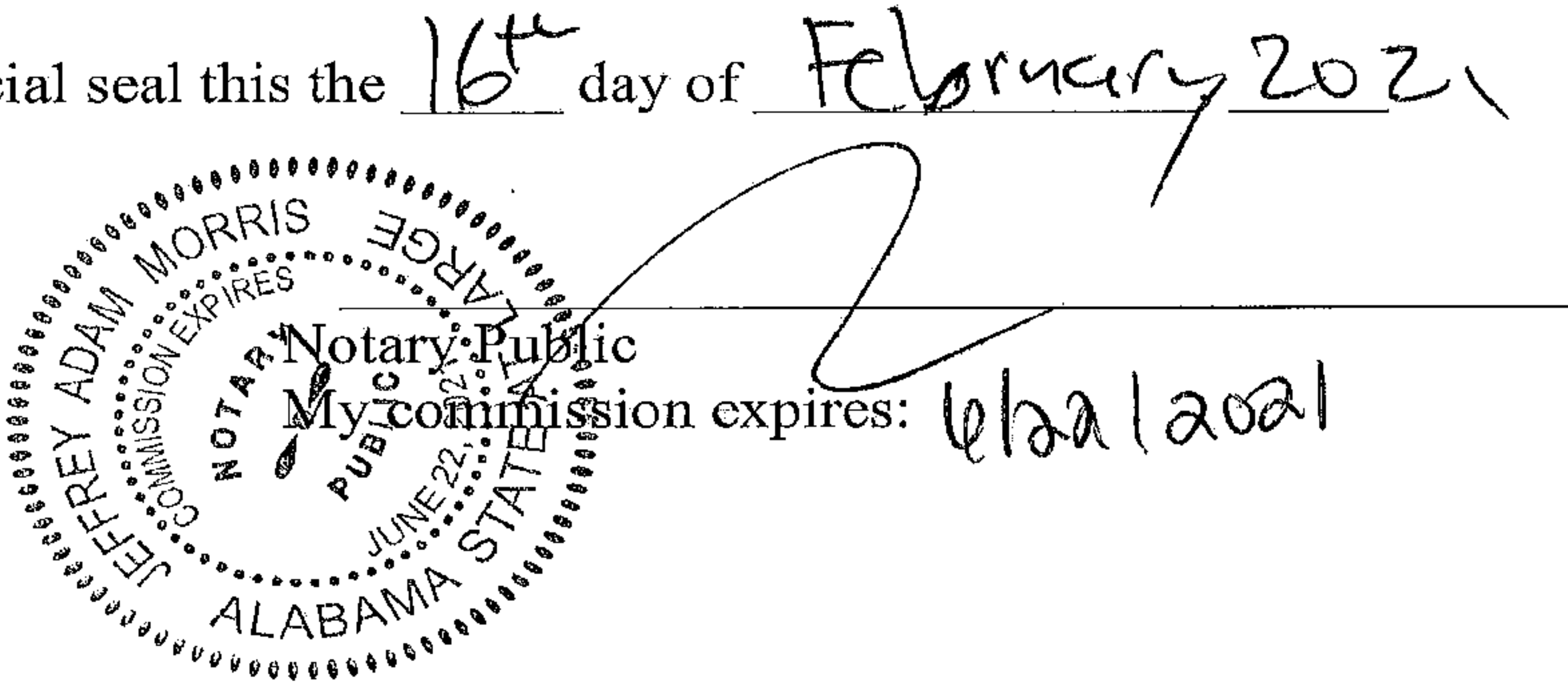
