George and Charlotte H. George, husband and wife** (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto **Richard H. Greene and Karen J. 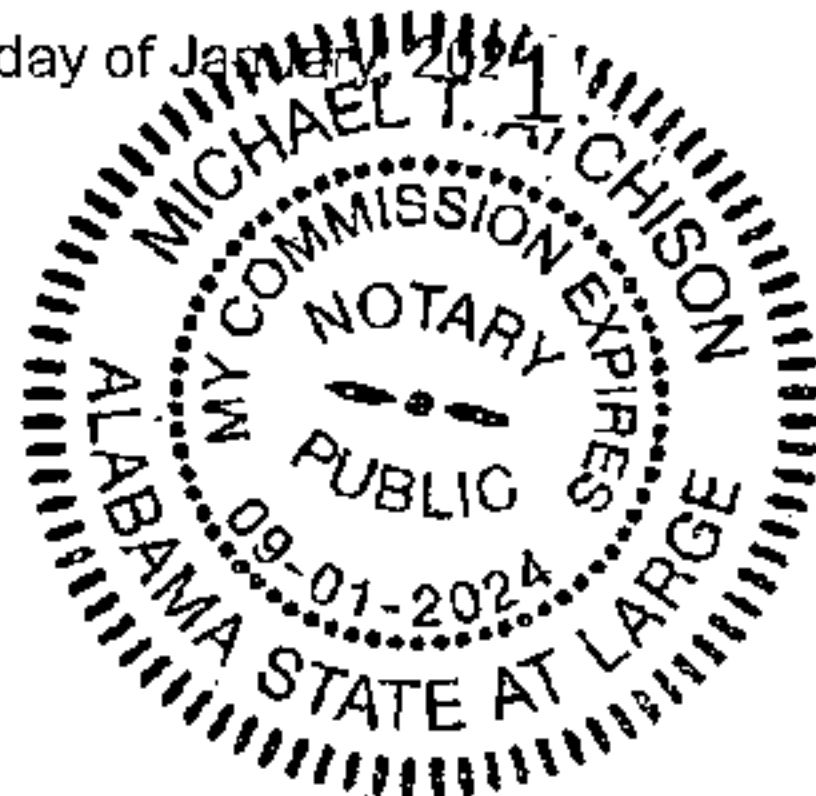

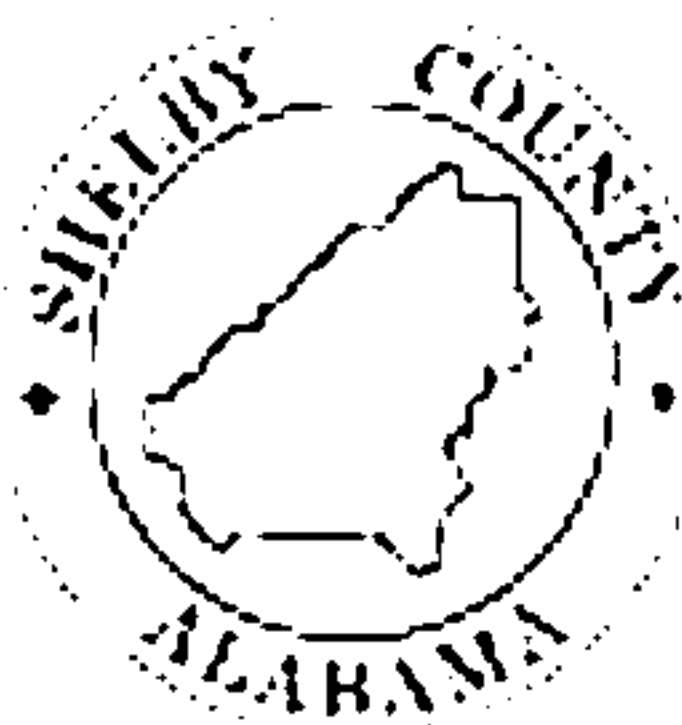
