KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on to wit, July 19, 2019, Natalie Noble, single woman, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., acting solely as nominee for FBC Mortgage, LLC, which said mortgage was recorded in Instrument Number 20190723000262410 in the Office of the Judge of Probate of Shelby County, Alabama; said mortgage subsequently transferred and assigned to PennyMac Loan Services LLC by instrument recorded in Instrument Number 20200729000315760 in the aforesaid Probate Office "Transferee" and

WHEREAS, E21 LLC was the highest bidder and best bidder in the amount of Ninety-Three Thousand And 00/100 Dollars (\$93,000.00) on the indebtedness secured by said mortgage, the said PennyMac Loan Services LLC, by and through Tiffany & Bosco, P.A., as attorney for said "Transferee", does hereby remise, release, quit claim and convey unto E21 LLC all of its right, title, and interest in and to the following described property situated in Shelby, County, Alabama, to-wit:

Commencing at the point where the Southern boundary of the Calera-Centerville Highway (Alabama Highway 25) intersects the Western boundary of the Southwest 1/4 of the Northeast 1/4 of Section 3, Township 24, Range 12 East; run thence South along said Western boundary 300 feet to the point of beginning; thence run in an Easterly direction parallel with the Southern boundary of said highway, a distance of 150 feet; thence run South parallel with said Western boundary of said Southwest 1/4 of Northeast 1/4 a distance of 100 feet; thence run West parallel with said Southern boundary of said highway a distance of 150 feet to the Western boundary of said Southwest 1/4 of Northeast 1/4; thence run North along said Western boundary to the point of beginning.

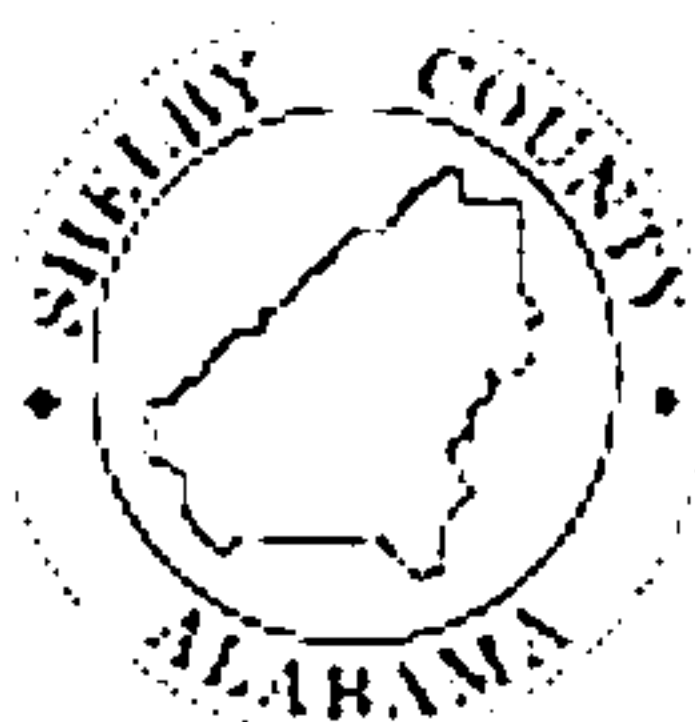
