For ad valorem tax purposes only, the address to the above-described property is 454 Eaton Road, Birmingham, AL 35242.

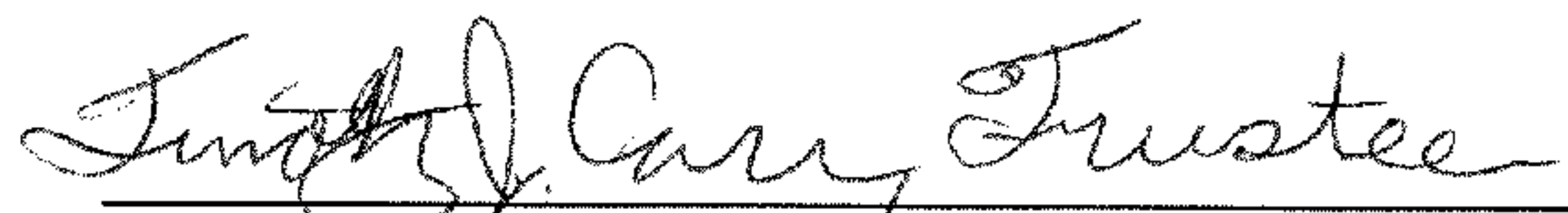
To Have and to Hold to the said grantee, their assigns forever.
