Subject to: Easements, Restrictions and Right-of-Way of record.

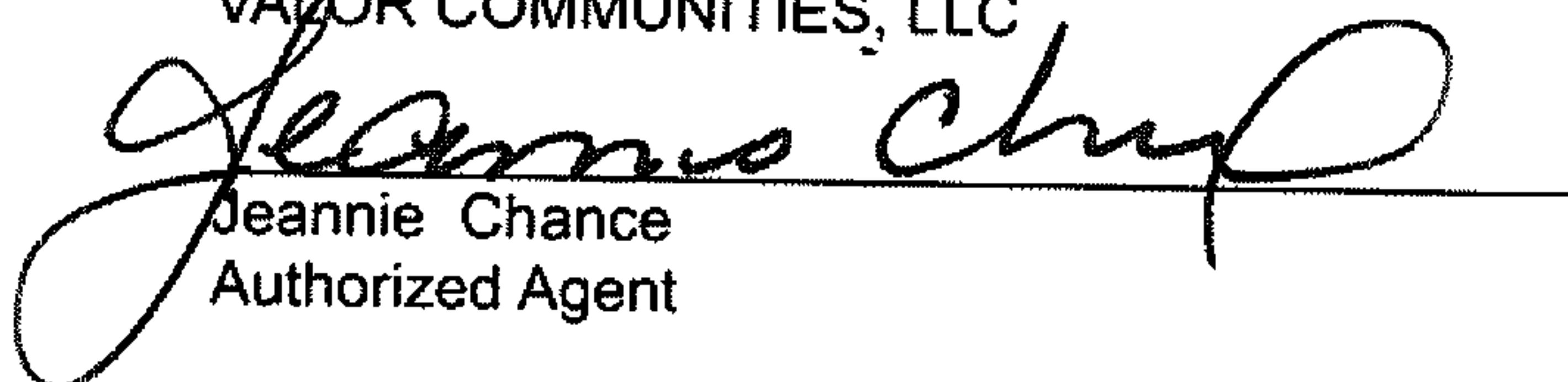

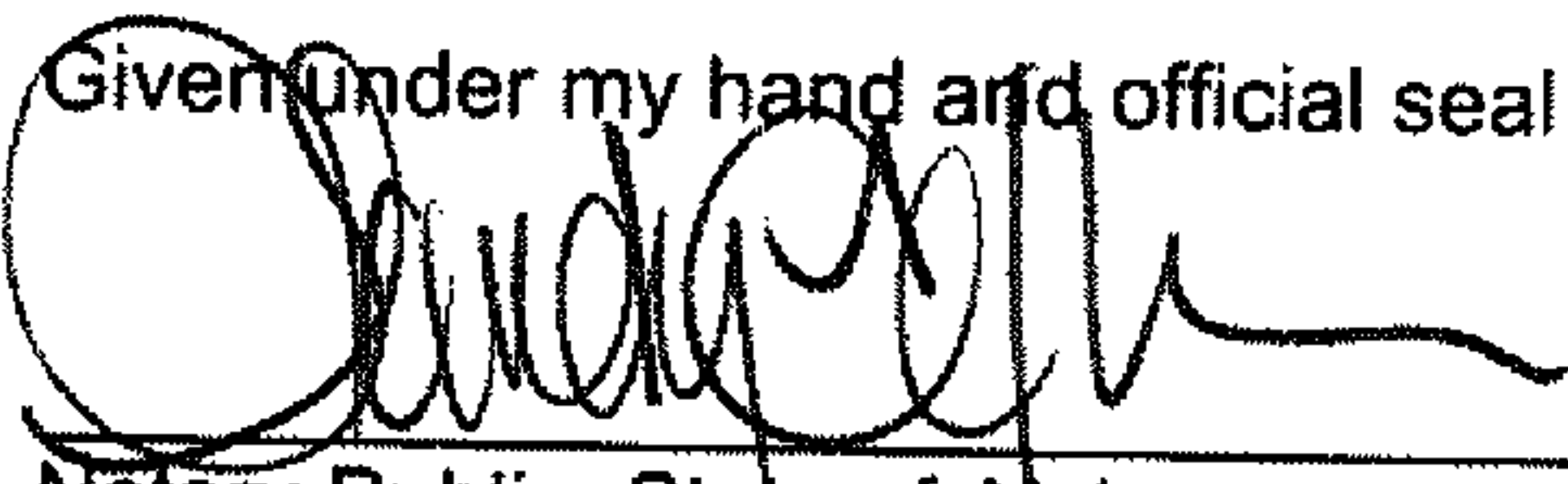

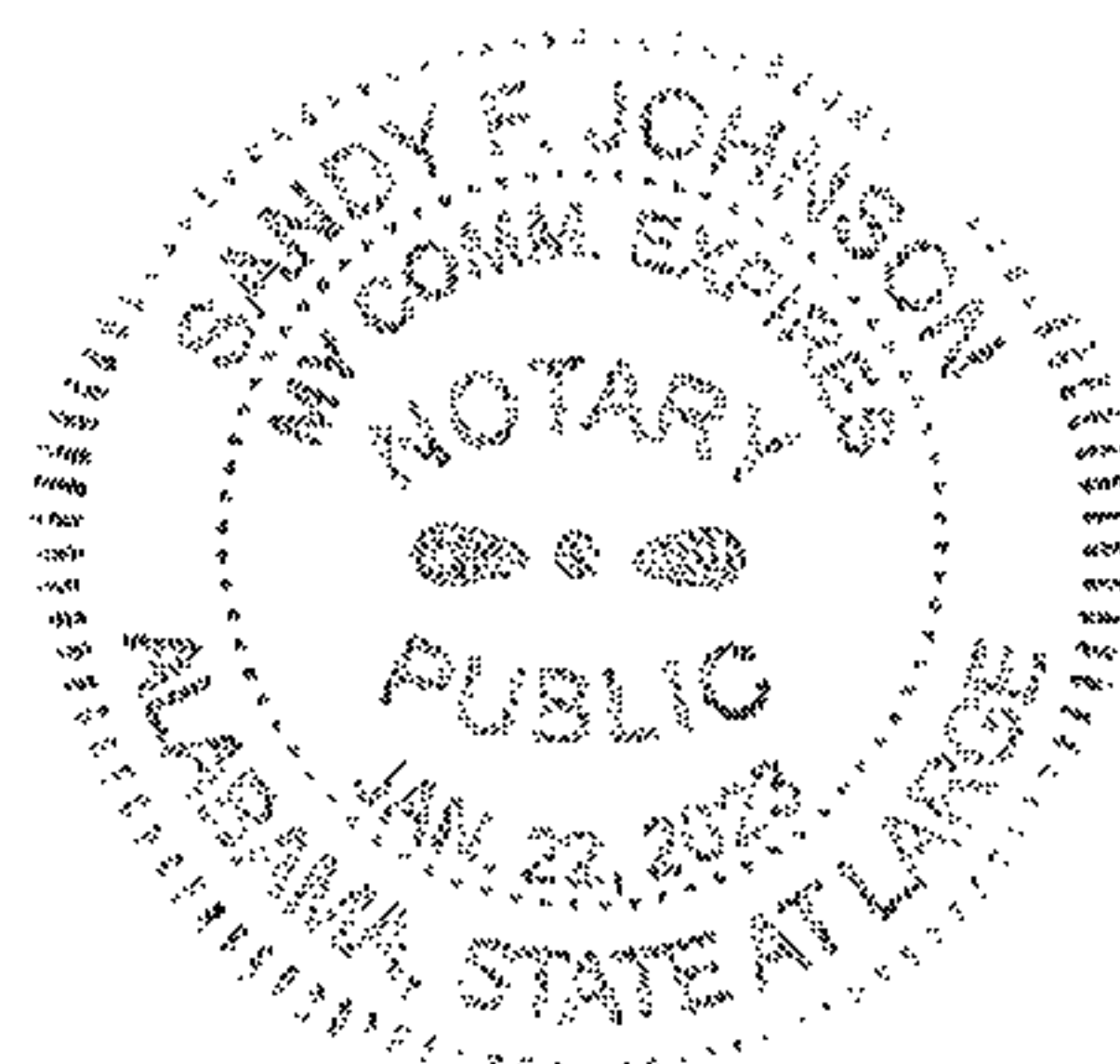
