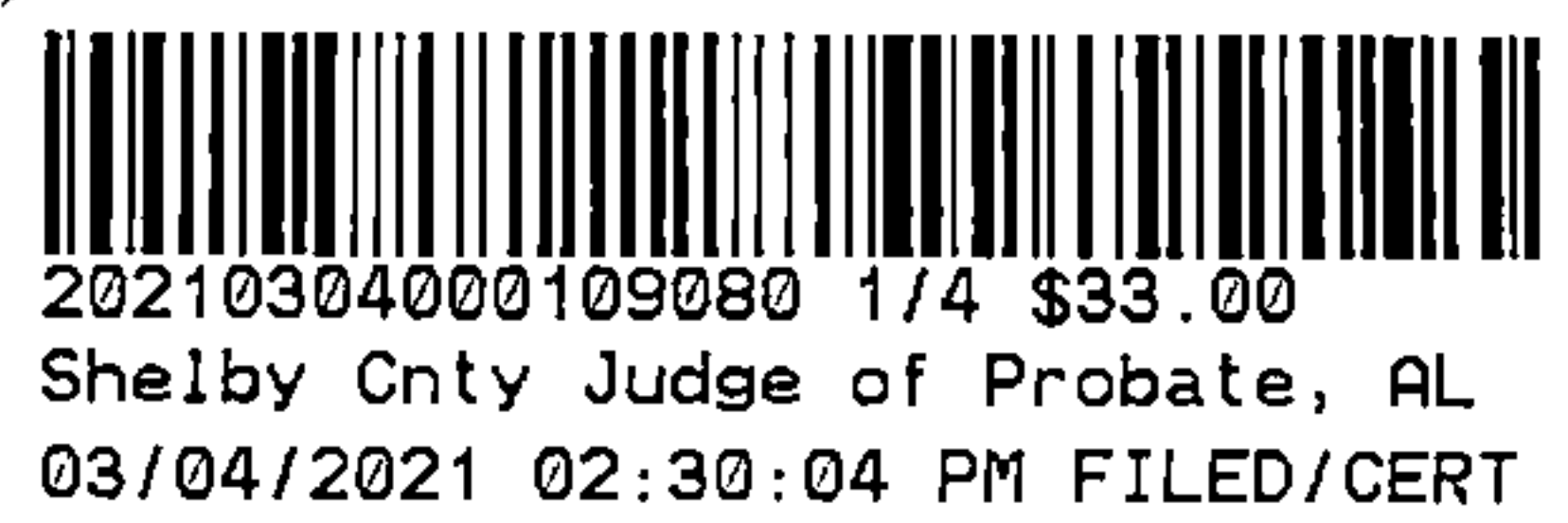

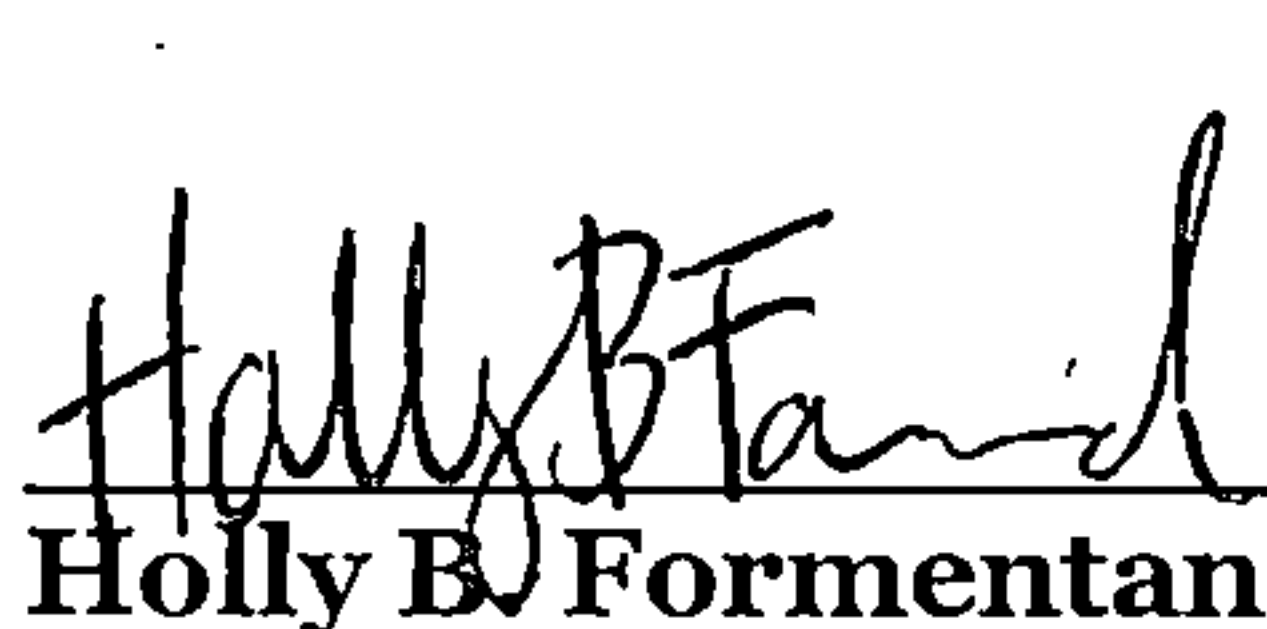
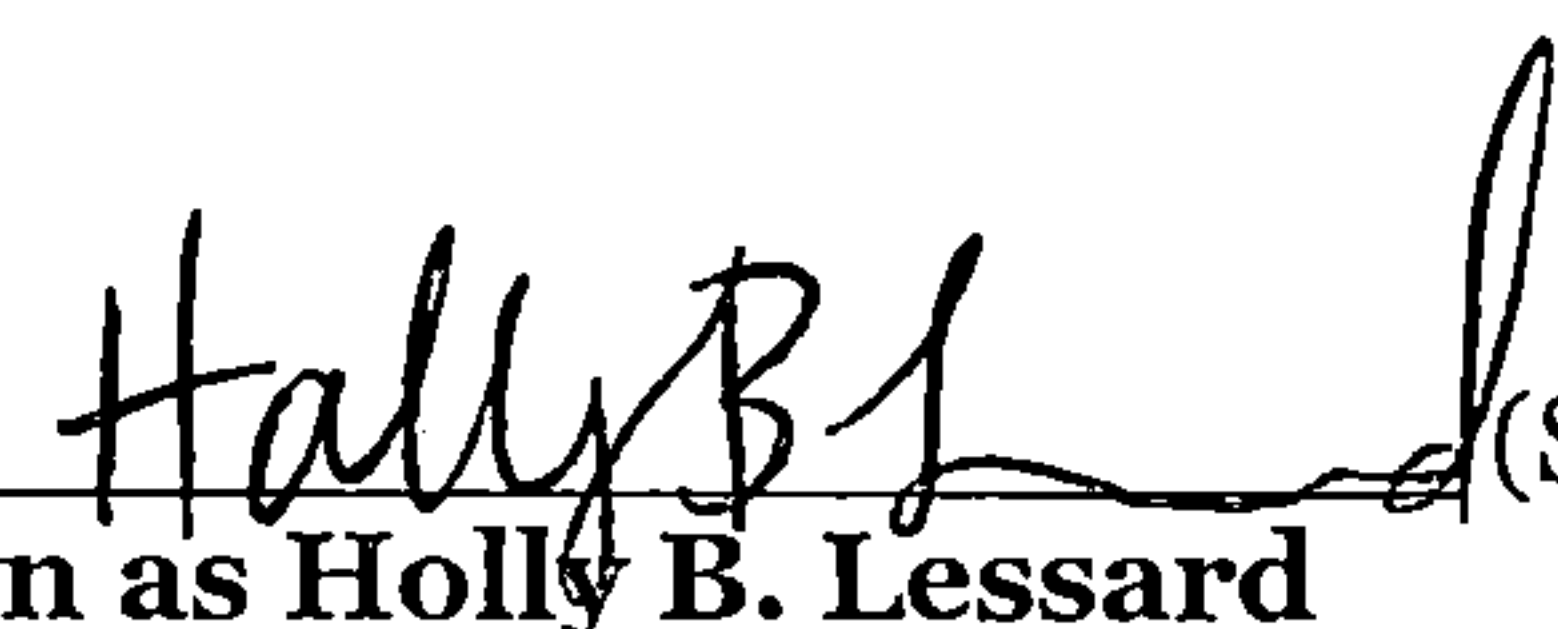
Holly B. Formentano is one and the same person as Holly B. Lessard.
