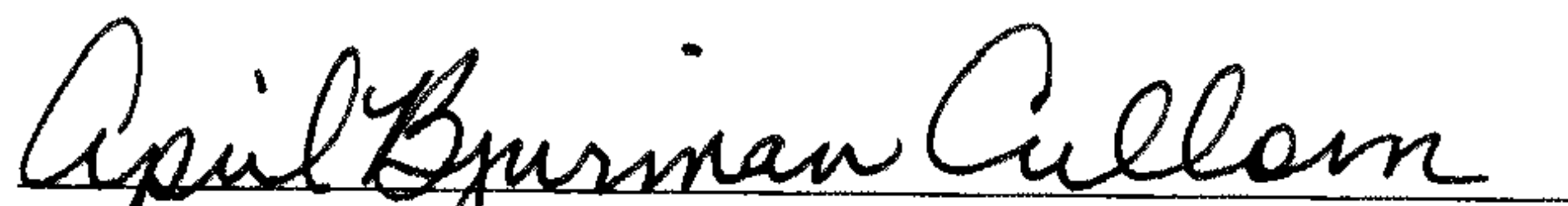
The herein described property does not constitute the homestead of Brenda W. Bjurman nor that of her spouse.

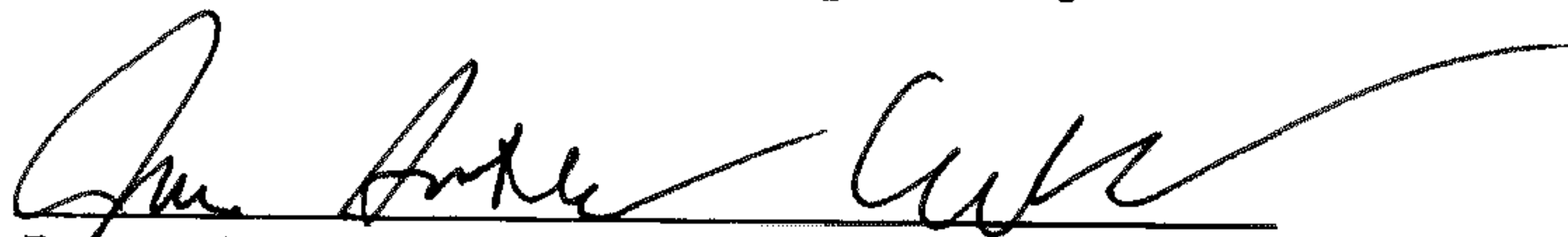

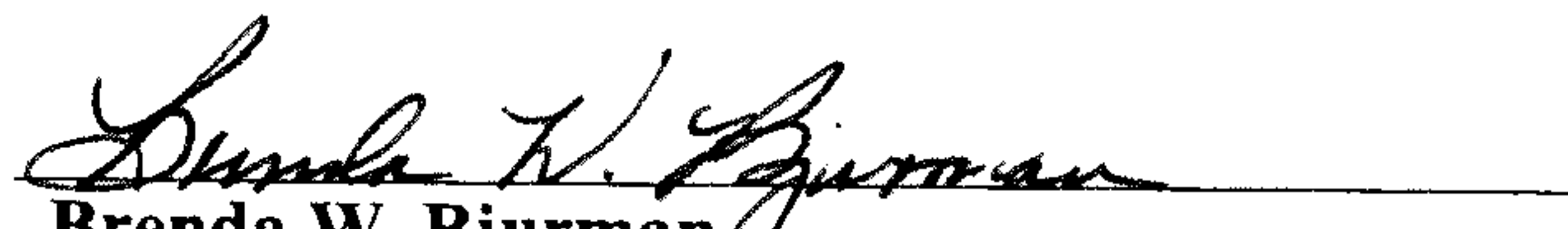
Subject to a third-party mortgage in the amount of \$174,600.00 executed and recorded simultaneously herewith.

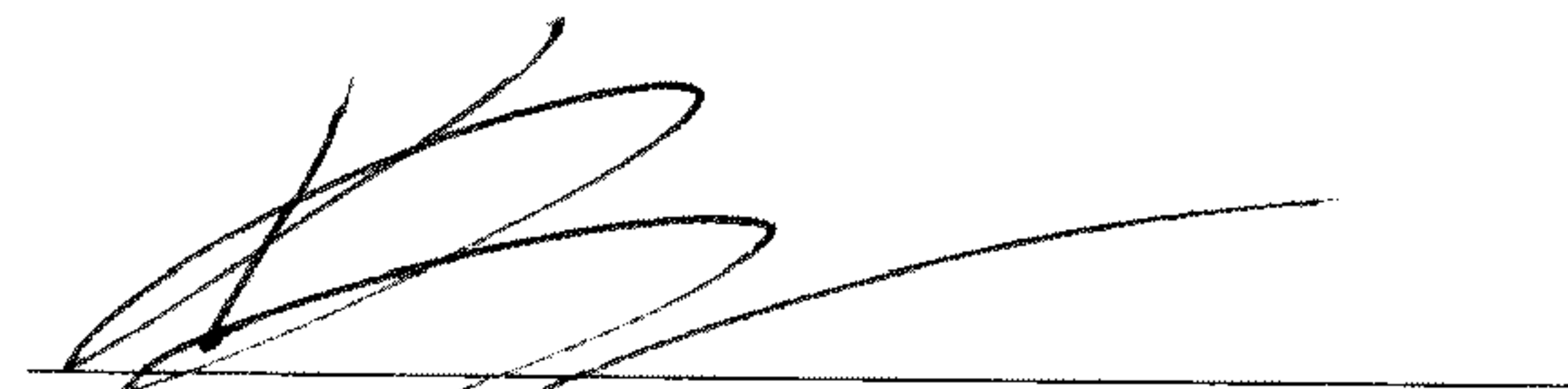

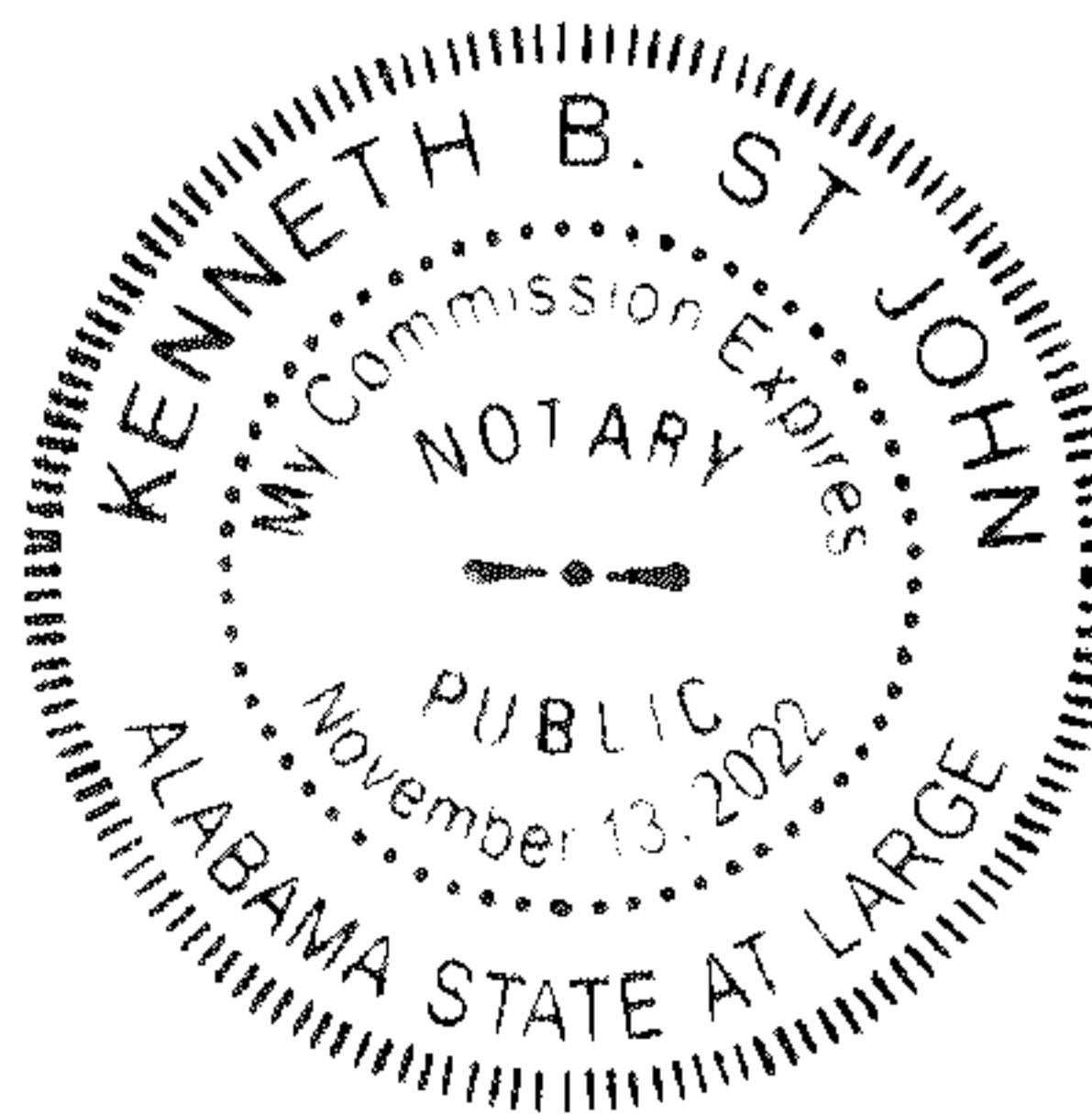
