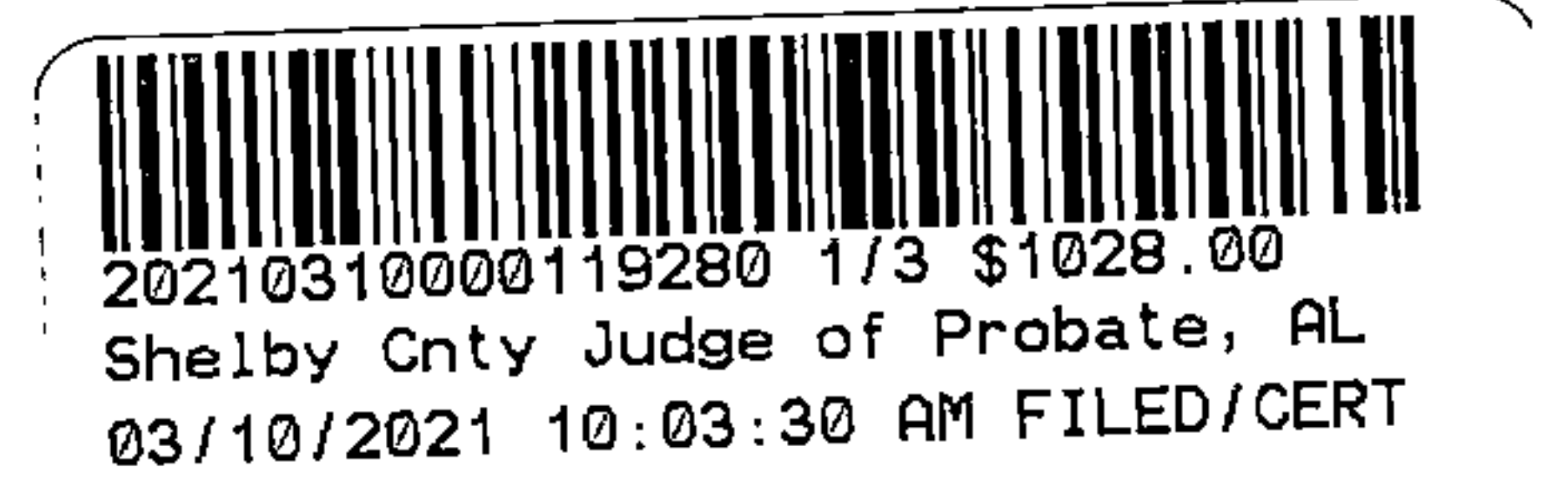

WARRANTY DEED

WAYNE LAGLE, an unmarried man**, (herein referred to as "Grantor"), in hand paid by the Grantees herein, the receipt whereof is hereby acknowledged, the Grantors does hereby give, grant, bargain, sell and convey unto the GRANTEE, **MICHELLE LAGLE**, (herein referred to as "Grantee"), Grantee's heirs and assigns, any and all of the respective Grantors' interest in the following-described Real Estate situated in, **SHELBY COUNTY, ALABAMA**, to wit:

Lot 1A, according to the Survey of Durkee's Resubdivision of Lot 1, Indian Crest Estates, as recorded in Map Book 46, Page 40, in the Office of the Judge of Probate of Shelby County, Alabama.

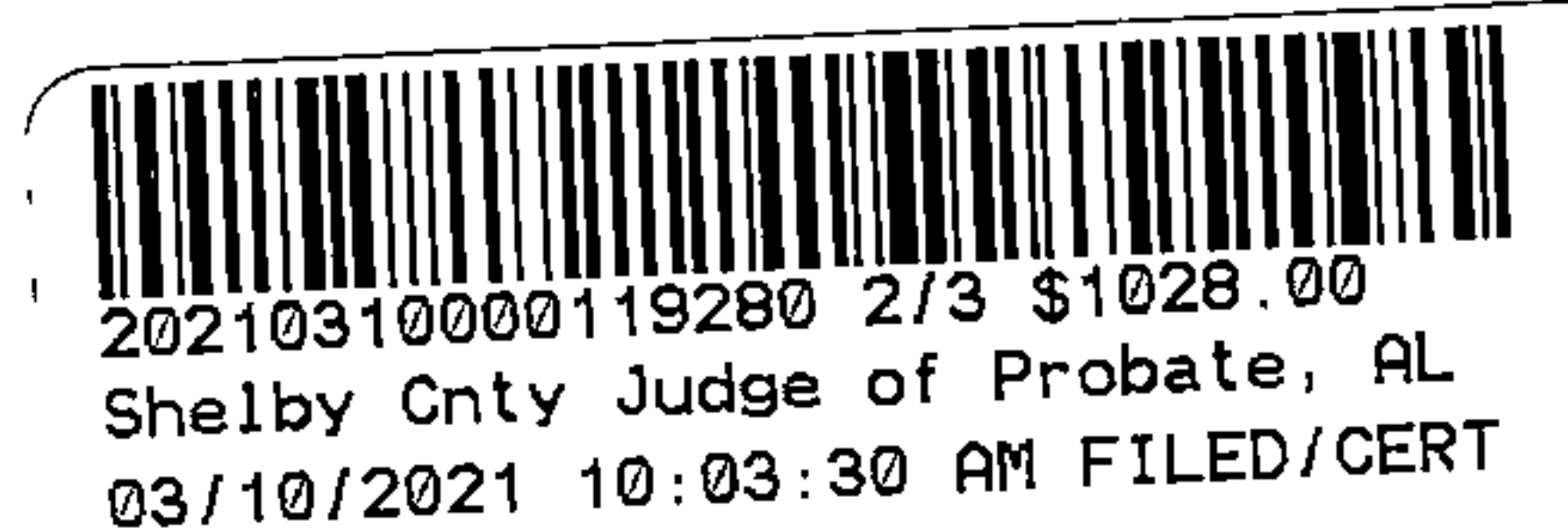
