**Subordination Agreement**

THIS AGREEMENT is made and entered into on this 3th day of March, 2021, by Regions Bank (Hereinafter referred to as "Regions Bank") in favor of Method Mortgage LLC, its successors and/or assigns (hereinafter referred to as "Lender").

**RECITALS**

Regions Bank loaned to William Dubose aka William Daniel Dubose and Marissa Dubose (the "Borrower", whether one or more) the sum of \$30,000.00 . *By its acceptance of this agreement, the borrower agrees to pay the subordination Fee set out in the Regions Subordination Request Form.*



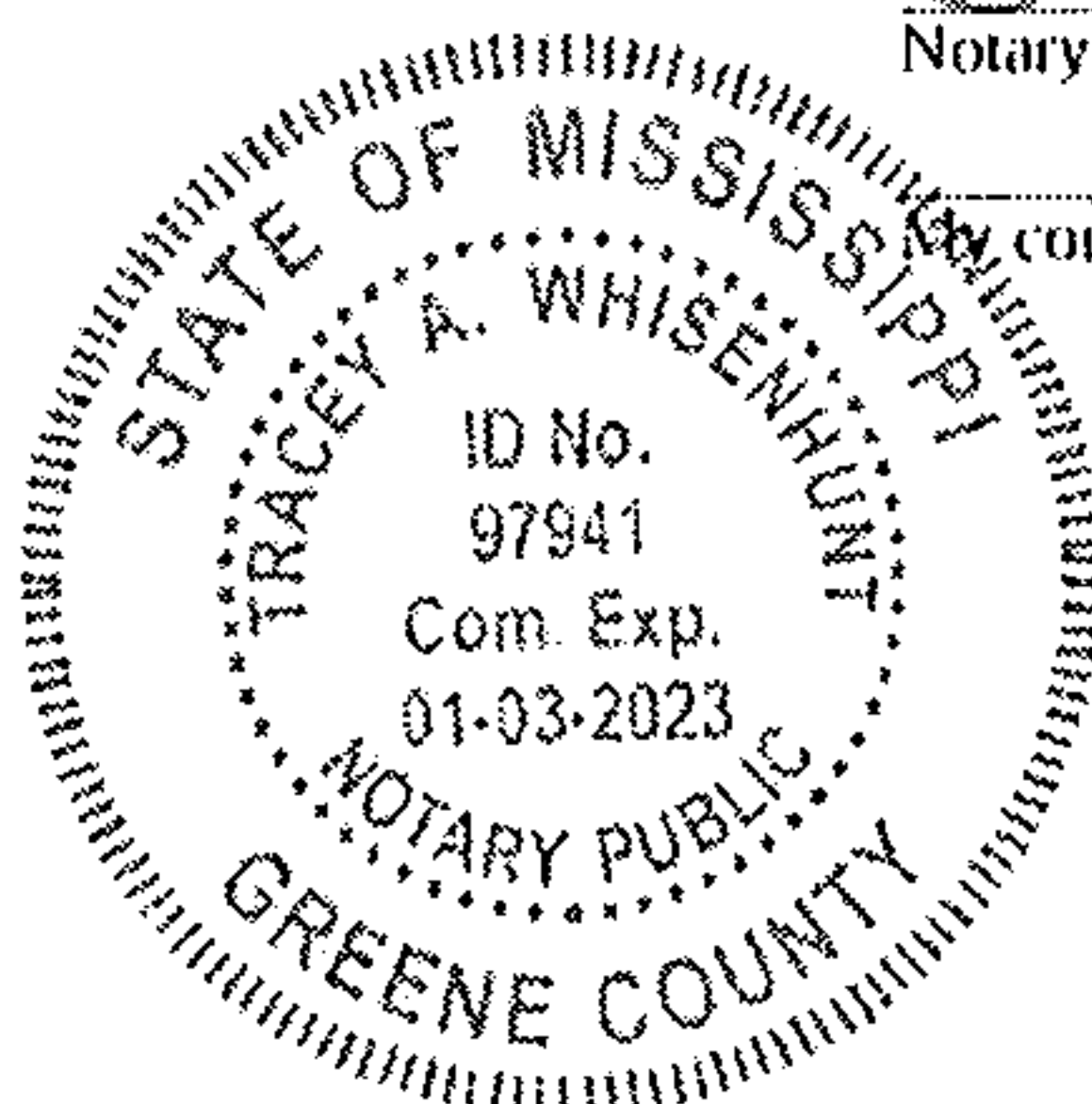
