
ORDINANCE NO. 399-06



AN ORDINANCE TO AMEND CHAPTER 2, ARTICLE II, SECTION 2-23, SECTION 2-24, SECTION 2-40 AND SECTION 2-41 OF THE CODE OF ORDINANCES OF THE CITY OF PELHAM - COUNCIL MEETING RULES OF PROCEDURE

WHEREAS, the City of Pelham has determined that it is in the best interest of the City to amend Chapter 2, Article II, Section 2-23, Section 2-24, Section 2-40 and Section 2-41 Order of Business of Council Meetings of the Code of Ordinances, City of Pelham, Alabama.

NOW, THEREFORE BE IT ORDAINED by the Council of the City of Pelham, Alabama, that Chapter 2, Article II, Section 2-23, Section 2-24, Section 2-40 and Section 2-41 Order of Business of Council Meetings of the Code of Ordinances, City of Pelham, Alabama and the order of business in all instances for meetings of the council shall be amended as follows:

I. ARTICLE II. COUNCIL MEETINGS

Section 2-23. Quorum.

A quorum shall be determined as provided by Section 11-43-48, Code of Alabama. The number of members required to make a quorum does not change when a council has vacancies. Council members who are present at a council meeting, but have recused or stated they have a conflict of interest on a particular issue, can be counted for the purposes of making a quorum, even though such council member is not voting or deliberating on a particular issue.

Section 2-24. Times of all meetings.

All regular meetings shall be scheduled for 7:00 p.m. at Pelham City Hall, and all meetings, regular and special, shall be open to the public. Should a conflict arise, the meeting time and place may be changed by the council with proper notice given. The Council President will be responsible for approving all draft agendas based on the input and requests received from the mayor, city manager, city clerk/treasurer, department heads, other council members and members of the public. Any item requested to be added to an agenda by two members of the city council will be added to the applicable agenda. City council agendas will not become final until approved by the city council during the city council meetings for which they apply.

Section 2-40. Bids submitted for consideration.

Deleted in its entirety.

Section 2-41. Attending meetings by officers and employees.

The city manager, city clerk/treasurer, city engineer, city attorney, chief of police, and fire chief and such other officers or employees of the City of Pelham, shall, when requested, attend all meetings of the council and shall remain in the council room for such length of time as the council may direct.
