Know All Men by These Presents: That in consideration of **Three Hundred Ninety-Four Thousand Five Hundred and 00/100 Dollars (\$394,500.00)**, to the undersigned Grantors, in hand paid by the Grantees herein, the receipt where is acknowledged, we, **SHAUN M. BATTISTE and DANA F. BATTISTE, husband and wife** (herein referred to as Grantors) grant, bargain, sell and convey unto **JASON STEDWELL and EMILY BROOKS** (herein referred to as Grantees), the following described real estate, situated in **SHELBY** County, Alabama, to-wit:

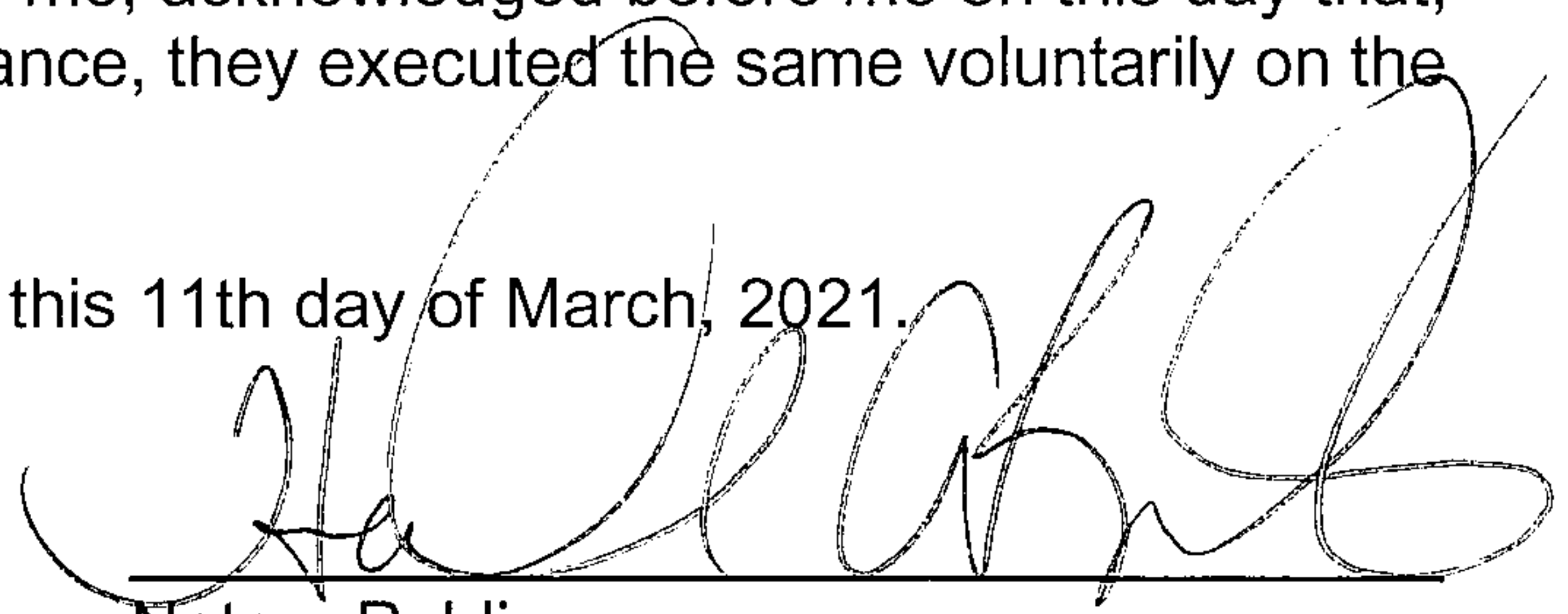
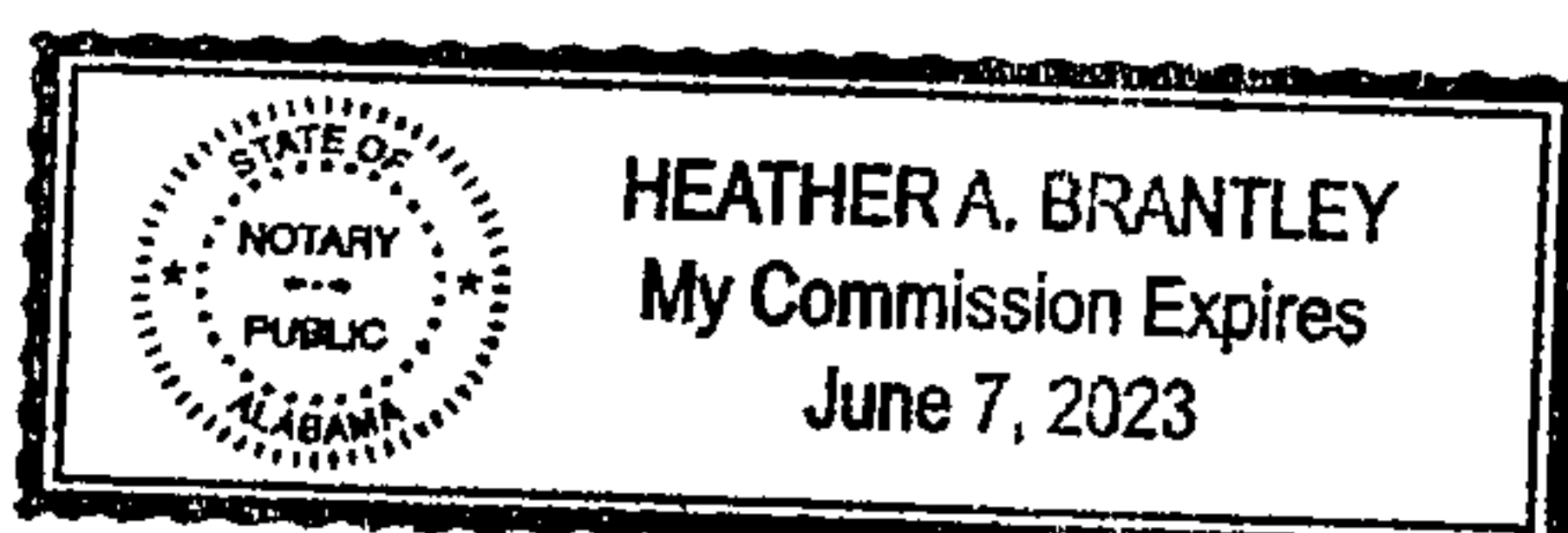

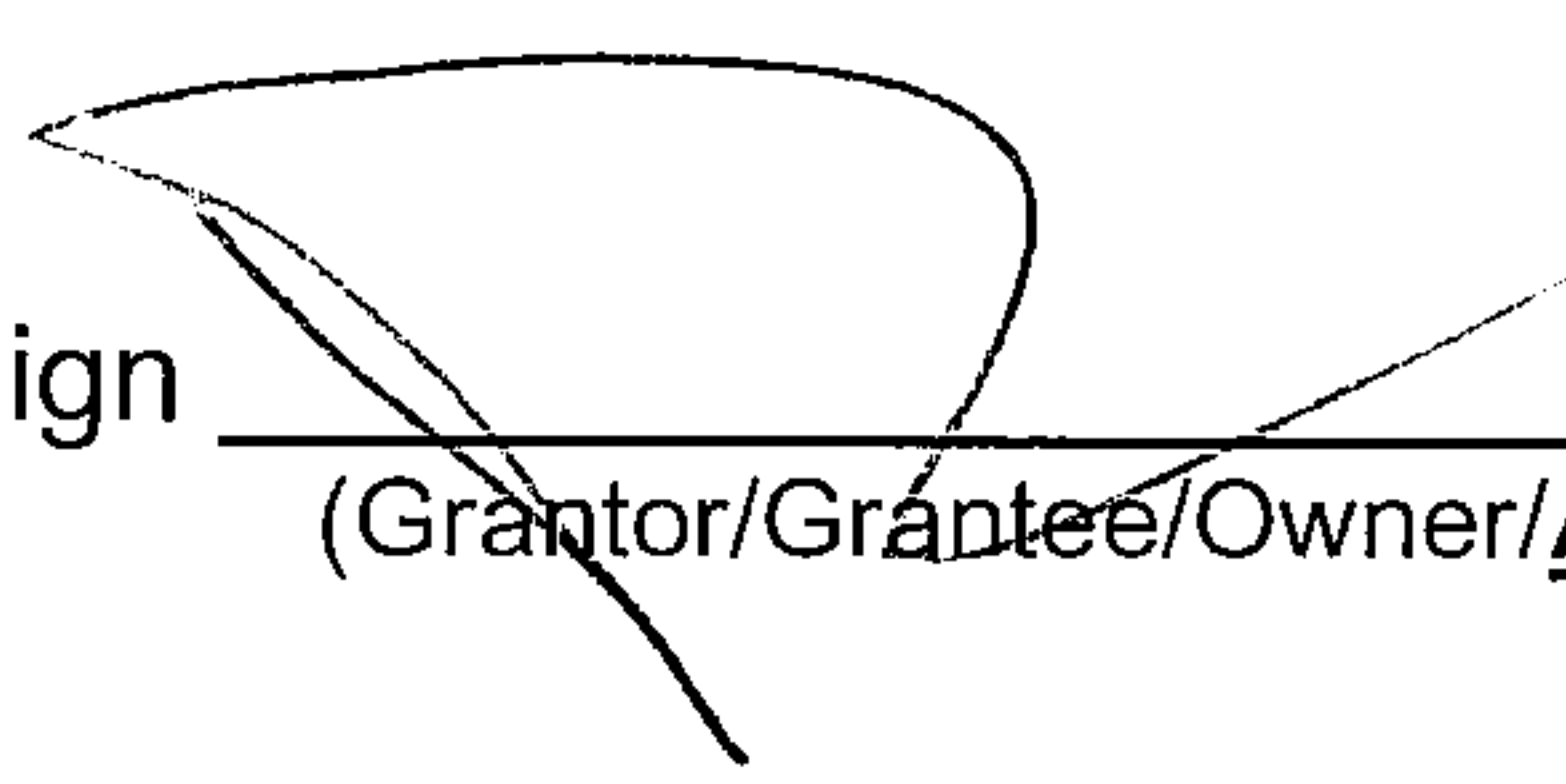
