KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration THREE HUNDRED SEVENTY TWO THOUSAND FIVE HUNDRED AND 00/100 (\$372,500.00), and other good and valuable consideration, this day in hand paid to the undersigned GRANTOR, **BRIAN A. RODRIGUEZ, an unmarried man** (hereinafter referred to as GRANTOR), the receipt whereof is hereby acknowledged, the GRANTOR does hereby give, grant, bargain, sell and convey unto the GRANTEES, **GEORGE G. PRATT and SHANNON C. PRATT**, (hereinafter referred to as GRANTEES), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described Real Estate, lying and being in the County of Shelby, State of Alabama, to-wit:

Lot 394, according to the Survey of Hillsboro Subdivision, Phase III, as recorded in Map Book 39, Page 123 A, B, and C, in the Probate Office of Shelby County, Alabama. Mineral and Mining Rights Excepted.

Subject to existing easements, current taxes, restrictions and covenants, set-back lines, rights of way and mortgages, if any, of record.

\$298,000.00 of the above-recited purchase price was paid from a mortgage loan closed simultaneously herewith.

GRANTEES, and GRANTEES' heirs and assigns, forever against the lawful claims of all persons.

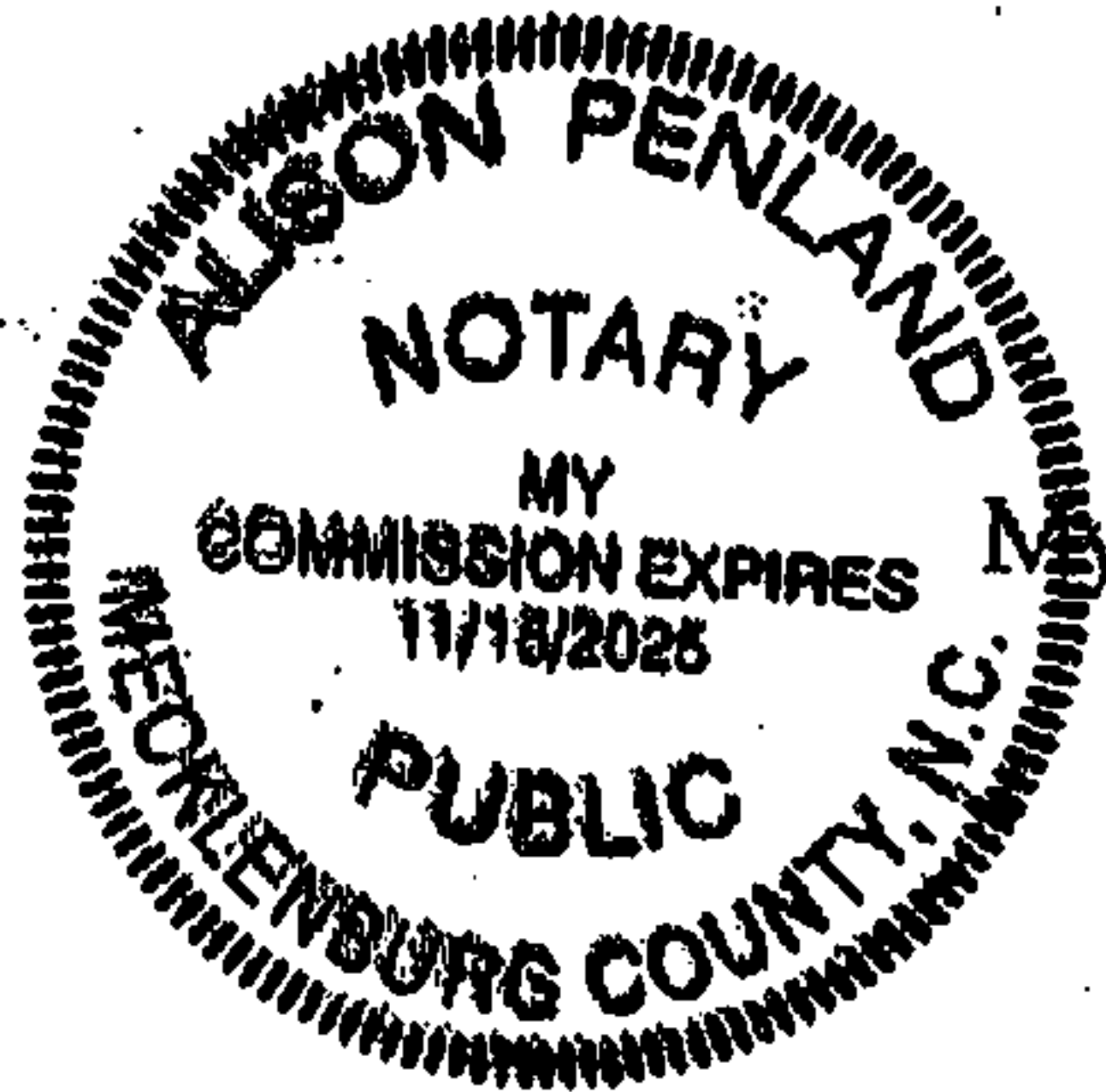
