Lot 1, according to the survey of Harless Homestead recorded in Map Book 51, Page 36, in the Probate Office of Shelby County, Alabama.

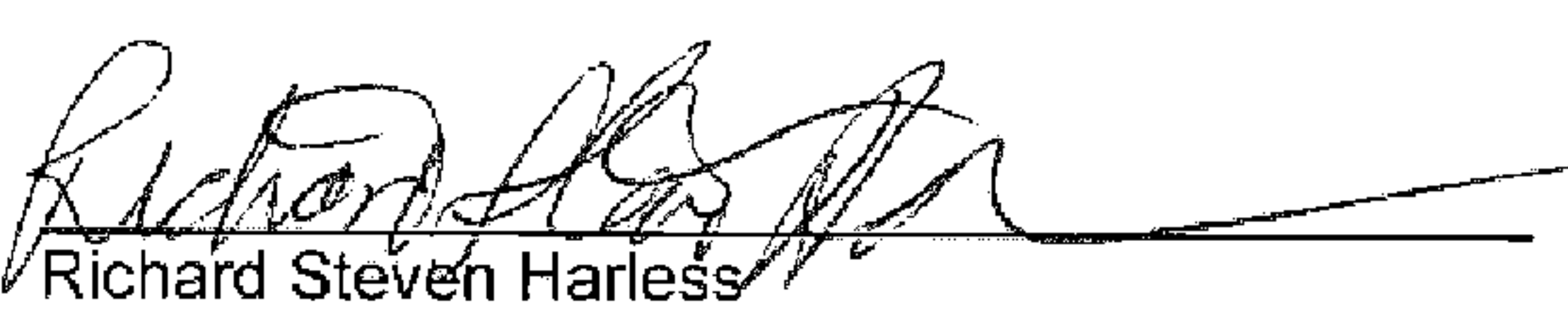

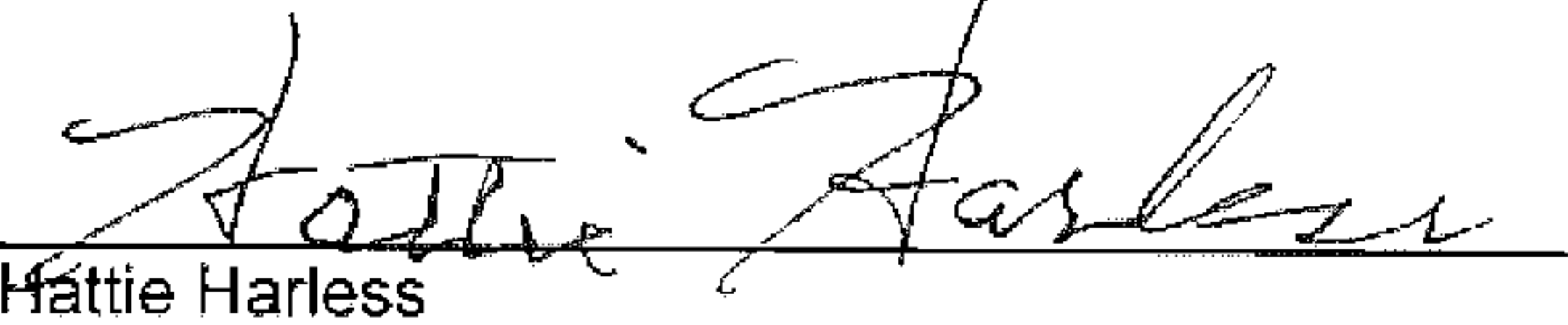
\$334,800.00 of the purchase price of the above described property was financed with the proceeds of a mortgage loan closed simultaneously herewith.

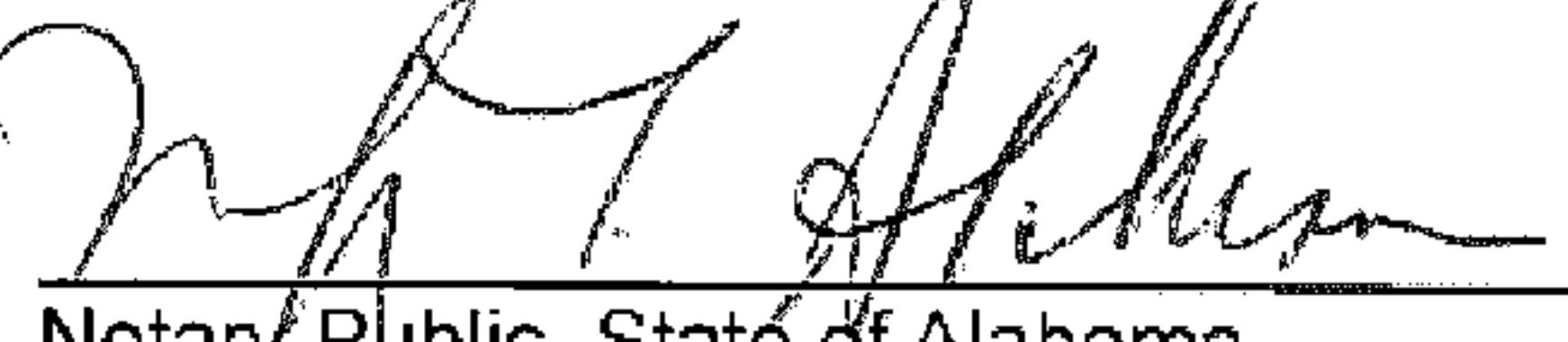

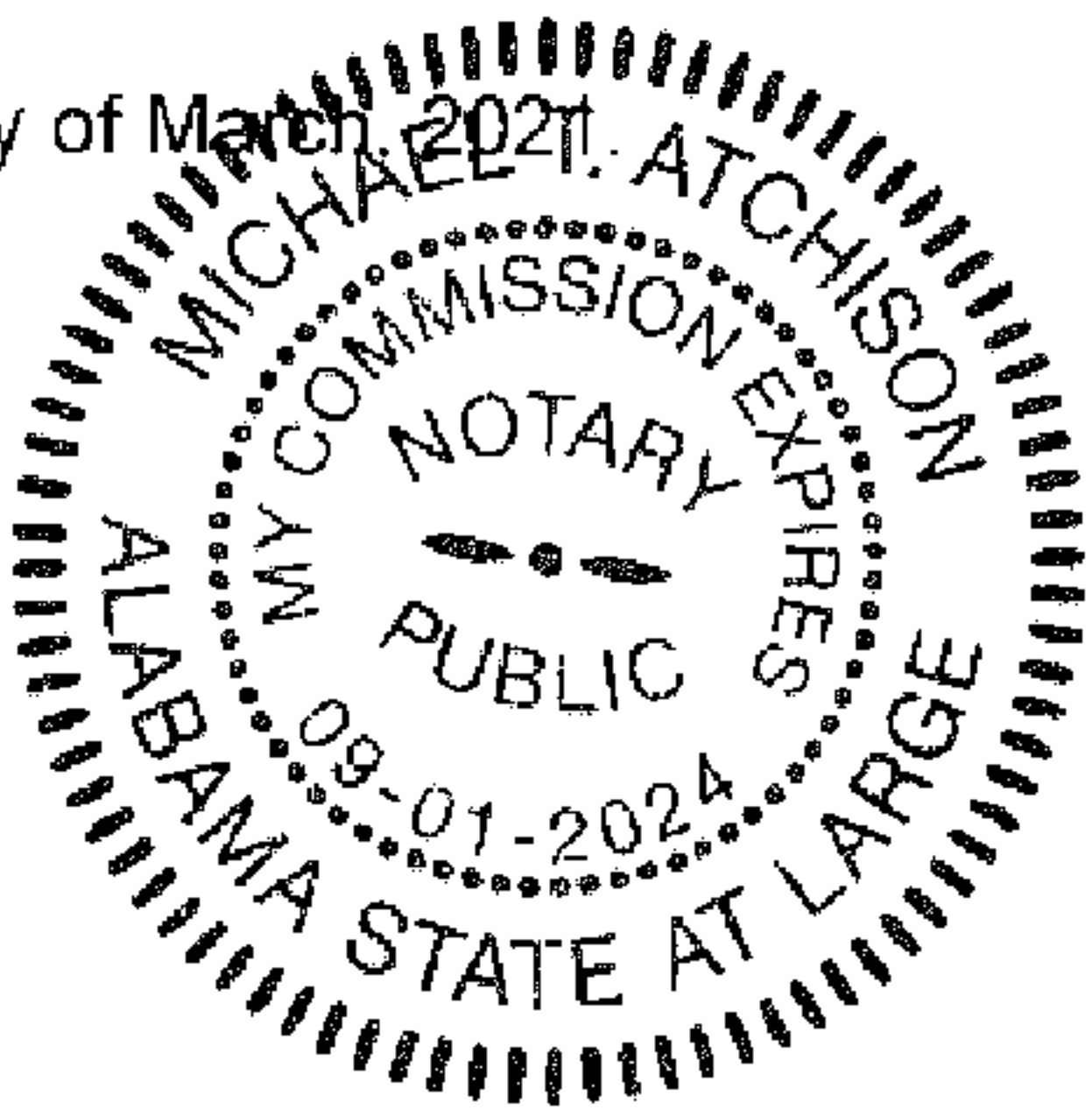

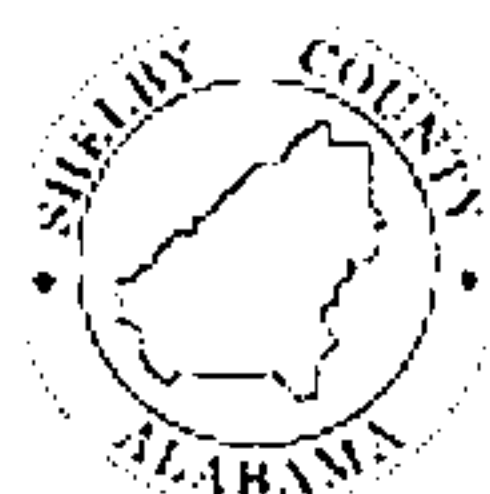
