A Power of Attorney Revocation is a legal document that revokes/terminates a present power of attorney and revokes any responsibilities or "power" he/she has regarding your legal matters.

### Why would I need it?

You need to issue a revocation of power of attorney document if you need to make any changes to the original power of attorney document or if you decide to name a new power of attorney.

### What do I do with this Form?\*

#### 1) Review

- Read through the revocation to make sure that all the information within is correct.

#### 2) Execution

- The person revoking this form must sign it in front of two witnesses and a notary.

#### 3) Post-Execution

- After the execution of the form, the form should be kept with the person executing this revocation.
- The form should be presented to any individual/organization that was previously relying on a power of attorney.
